August Program

The August general meeting of AOF will feature Paul Storey and Dave Flanders and their presentation titled "Evolution Versus Creationism As An Explanation of Life."

A slide show will be presented contrasting Creationism and the theory of evolution. Evidence supporting evolution will come from the sciences of geology, anatomy, physiology, embryology, genetics and immunology in a very understandable and visual manner.

Pictures from geology will illustrate the vast expanse of time which has preceded us. The flow of life through time will be depicted by the fossil record highly visible to anyone who has hiked to the bottom of the Grand Canyon where you go back a billion years in earth's history. Graphic illustrations from leading publishers will richly depict forms of life throughout earth's history -- roughly from cell to multi-celliular sphere, to worm, to fishes, to amphibians, to reptiles, to primates to man.

The philosophical implications of evolution will also be addressed. At the end of the presentation the audience will have a better understanding of evolution and why it is such a sensible and powerful idea with broad implications of our place as part of nature.

Be sure to attend this very enlightening presentation on Sunday, August 11 at noon. The meeting will be held at the usual place, the Sierra II Community Center, Room 10.

Report - July Speaker

Brian Johnston, the Executive Director of the Human Dignity Institute of Sacramento was the guest speaker at the July general meeting. His presentation was titled "What's Wrong with Assisted Suicide."

Mr. Johnston acknowledged that issues involving death are very emotional issues and that there are no easy answers. He mentioned court cases in the 9th and 2nd Federal Circuit Courts which may be taken up by the Supreme Court. Both of these Courts upheld the right to assisted suicide, which is currently legal only in the states covered by these two circuits. The speaker said that he does not believe assisted suicide should be legal He believes that in most cases, requests for suicide are a cry for help or attention.

Johnston said that historically, our society has not dealt with death well. Before the 1940s, individuals witnessed death more frequently than we do. People died at home with their family members. Death was a part of life in a natural way. We as a society, are missing out on the grieving process. The speaker mentioned a book titled "On "Death and Dying" by Elizabeth Kubler-Ross, in which the author writes about how all cultures throughout history have dealt with dying. She states that there five emotional stages which a dying person often experiences. Johnston pointed out that many times, when people are in the "anger" stage, they often want to "get it over with." He also pointed out that, according to Kubler-Ross. there are psychological benefits from going through the latter stages, for the dying person and for their family and friends.

Mr. Johnston suggested that most of the people whom Jack Keovorkian assisted to commit suicide were not actually dying.

The speaker said that he does not believe that protection for the medically dependent and depressed individual means keeping them alive needlessly or unnecessarily He feels that assisted suicide is not about "letting" people die. He advocates letting people die rather than keeping them on life-support machines. Johnston does not believe that assisted suicide is a natural death--it is lethal and designed to kill and nature has nothing to do with it.

The speaker suggested that poor pain management could be the reason that some people seek assisted suicide. He stated that pain can be managed and if it is not, the patient should probably get another doctor. Modern medicine can deal with pain. Some doctors, however, have had no training in pain management. As of 1987, Medical Doctors in California must be trained to manage pain.

Mr. Johnston pointed out that the AMA is opposed to assisted suicide. He then handed out a quote by Dr. Leo Alexander who worked with the Chief America Counsel at the Nuremberg Tribunal, which draws some comparisons between assisted suicide and the Nazi holocaust. DR Alexander stated that the crimes "started from small beginnings. The beginnings at first were merely a subtle shift in emphasis in the basic attitudes of physicians...the infinitely small wedged-in lever from which the entire trend of mind received its impetus was the attitude towards the non rehabilitatible sick."

The speaker concluded by stating that there is a distinction between pain and dying. He also concluded than the deep issue exists as to whether we can kill people who are very vulnerable.

Brian Johnston's talk at the AOF meeting on July 14 regarding a person's right to life -- or death -- was thought provoking and brought up important points to consider. What was left un-said, however, but was very much central to the entire discussion, was the assumption that it is the proper role of government to regulate how a person may or may not deal with his own life. Do I own my life? Or does the government own my life? Certainly all the factors relating to continuing or ending one's own life should be carefully considered, and it is healthy to discuss the ramifications. But the right to make the decision belongs solely to the owner of that life. Some people may believe one's decision to be wrong, but it is also a person's right to be wrong -- to make a mistake. Who has the right to make my decision -- me, or the government?

"Opportunity Scholarships"

Let's call it by it's real name - vouchers. Hearings for Assembly Bill 3180 took place on July 3, 1996 in the Senate Education committee and was soundly defeated in a 4 to 1 vote. This bill would have given "opportunity scholarships" (vouchers) worth about \$3,200 to students who wish to transfer out of schools which score in the lowest fifth percentile on achievement tests and into a private school.

Introduced by Assemblyman Speaker Curt Pringle, Republican, From Garden Grove, this bill passed in the Assembly earlier in the year. Representatives for 23 groups were listed in opposition to the bill and several spoke at the hearing, including Marty Kassman from the

ACLU, a member of the California Teachers Association and me. a concerned citizen. The scrutiny centered on the fact that public money would go to religious or other private schools. In an effort to emphasize the discrimination that exists in private schools, I asked if the private schools could refuse students - turning away students who were low-achieving, had behavior problems, or learning disabilities. The response was affirmative. If this bill had passed, holders of the opportunity scholarships would have been free to submit the vouchers to private schools which discriminate during the enrollment selection process.

Being a watchdog over what bills get through committee takes dedication and diligence. Initially I attended hearings on June 26 for several hours only to learn that the hearing on AB 1380 was to be postponed. Then on July 3, I once again attended hearings for seven hours before AB 1380 came up and those of us with opinions were allowed to be heard. I could see that electing representatives who share your philosophy is most valuable. There were several on the Education Committee who expressed concern that the public school system should be preserved and improved and not dismantled by charter schools, home schools, or vouchers. While in attendance I noted that this committee voted down at least three bills which included some type of charter school.

With the new state budget, class size will be lowered to 20 students per teacher in kindergarten through third grade. This is excellent news; something I have advocated in letters to the Sacramento Bee for several years. Now, if only the school districts will diligently and quickly put the legislators' directives into operation.
