Herb Silverman is a Professor of Mathematics at the College of Charleston. From 1990-1997 he fought the unconstitutional provision in the South Carolina Constitution that prohibited atheists from holding public office. He founded the Secular Humanists of the Lowcountry in Charleston, SC. and is founder and faculty advisor to the College of Charleston student Atheist/ Humanist Alliance. Herb is spokesperson for the SC Secular Council. A board member of Atheist Alliance and American Humanist Association. Herb is also regional director to the Council for Secular Humanism, advisory board

member of the Secular Student Alliance: and founder of the Coalition for the Community of Reason (an umbrella group of ten national freethought organizations). He will talk a little about his challenge to the South Carolina Constitution, which prohibited atheists from holding public office. He will then speak about his challenge to the freethought movement to spend more time cooperating than competing. We have met the enemy, and it is NOT us. It is the likes of Ashcroft, Falwell, and Robertson. We will discuss ways we can work together and make a difference in our community of reason.

On Friday, June 28, 2002, when our treasurer Ken Nahigian opened the envelope, much board anxiety evaporated. Whew! Hooray! Hey, we did it! We received our much-hoped-for "letter of determination" from the Internal Revenue Service, and it pronounced AOF's tax exempt status as a 501(c)(3)! This is an important "promotion" for the club, and something we all can celebrate while we bewail this ghastly U.S. Supreme Court voucher ruling. The Supremes have created a huge gaping hole in our wall, the same wall that has enabled our unique experiment in government to flourish for two hundred years.

At this point, nonreligious people had better do more than their usual lamentations. There is a need to step forward, be visible and, yes, be political. *The times*, dear friends, *they are a-changing*.

The AAI Connection A Look at the AAI's Award-Winning Website

The AAI Web site may well be the Internet's premier freethought web site, with encyclopedic information and links to freethought around the world. With the leadership of Joe Zemel and Dave Feroe, this site has received awards, including being named the essential atheist link by Yahoo. Those who haven't yet explored the site should visit when they have some time to spend checking out the extensive information and entertainment it offers.

Of the twenty items listed at the top of the home page, several are of special interest. The Freethought Directory, an abridged version of the book, allows the visitor to get contact information on freethought organizations around the world. Click on Awakenings, and you find a collection of short quotes on becoming atheist. Links to atheism on the Internet are catalogued, so the visitor clicking on Bible and Criticism, for example, will find nineteen different sites to explore.

There's a page discussing Family Issues, and the Library with essays, pamphlets and poetry. Local groups can download their preferences from a variety of animate and inanimate graphics.

Scroll down the page to In the News, where the 2002 Convention photos are posted. Or check out the forum for Young Atheists, an egroup for teens and preteens

Book and video recommendations offer links to Amazon.com and Amazon.co.uk. The latter, for the United Kingdom, offers some material not offered in the U.S. Purchases made through this link reap the Alliance a cut of five to fifteen percent of the total purchase, money that may find its way back to your local group as a matching grant.

With this standing, members can now more readily participate in payroll deductions or various donation mechanisms.

AOF owes many thanks to **Paul Geisert** for his efforts in spearheading this project. He really took this bull by the horns in January, and he put in many hours since while carrying the application process to fruition. Paul had to deal with an awkward timeframe, too! (The process began with our "old board" and then we elected a "new board.") A bit of legal advice from **Greg Elvine-Kreis** helped Paul negotiate those additional hurdles.



Editor's note: Since the June meeting, the case on inauguration prayer has been dismissed (Judge Karlton found that the court had no authority to restrict a president from acting in a particular fashion.) On Wednesday, June 26, 2002, the Ninth U.S. Circuit Court of Appeals ruled 2-1 in favor of Mike in another case, finding that Congress violated the Constitution's establishment clause by adding the words "under God" to the Pledge of Allegiance in 1954.

Meet AOF Board

New board member Jerry Sloan is a charter member of AOF. Like many atheists, his journey to atheism has been a life long trek.

A native of Kansas City, MO., born on August 18, 1937, he was raised in a Fundamental, Independent Baptist Church and attended Baptist Bible College located in Springfield, MO, where he graduated in 1957 with a degree in theology. Jerry Falwell was a schoolmate.

As a teenager Jerry knew he had an attraction for men but in those days there was no support or counseling for people who were homosexual. In 1961 his church asked him to leave when it was suspected that he might be homosexual.

In 1973 he joined the Metropolitan Community Church, a Christian church whose communicants are primarily gay and lesbian. He became a licensed minister and served congregations in Kansas City, Des Moines, Wichita, Ft. Worth and Sacramento.

As a result of his bible studies, Jerry began to doubt the validity of the stories in the bible and eventually came to the conclusion that the stories therein were indeed myths.

Jerry has been an out-front civil rights activist, especially on gay and lesbian issues.

In Sacramento he became a member of the committee that planned the gay pride celebrations and in 1984 help found the Lambda Freedom Fair held each year in June. In 1986 he helped open the Lambda Community Center located at 20th and L Streets to serve the gay, lesbian, bisexual, transgendered communities of Sacramento, and he served as president of the Lambda Community Fund for seven years.

Member — Jerry Sloan

In 1991 Jerry became alarmed about the rising political movement of the radical religious right and help start a watchdog group called Project Tocsin - a tocsin is an alarm signal - to monitor their activities by looking at public records and attending public meetings.

He is best known for his 1984 breach of oral contract lawsuit against Jerry Falwell, which he won, collecting nearly \$9,000 from Falwell. A portion of the proceeds was used to start the Lambda Community Center.

Jerry is excited about being a new board member and wants to work to help AOF become better known in the Sacramento area.

A Freethinker of Note—Mohandas Karamchard Gandhi By Kenneth Nahigian

This month's famous freethinker was born in 1869. At age 13 his family pushed him into an arranged marriage. Two years later he visited his ill father, but left early to hurry home and have sex with his wife. Shortly after he left, his father died. Wracked with guilt, the young man forswore all physical pleasure and became a lifelong ascetic. I'm guessing, but his wife was probably pretty ticked.

His name was Mohandas Karamchard Gandhi.

As a law student in London, Gandhi took an interest in music and religion. Equally impressed with all religions, he was partisan toward none, except that he became outspoken about vegetarianism.

Passing the bar in 1891, he went to Southern Africa and worked to improve rights of immigrant Indians there. There he evolved a creed of passive resistance, *satyagraha*, meaning "truth force." Protests frequently landed him in jail. But before returning to India in 1915, he had radically changed the status of South African Indians.

Hailed as a celebrity in India, Gandhi agitated for fair labor conditions, especially for textile workers. He opposed indentured servitude, fought the cast system, and advocated Indian-Muslim unity. He also called for "home rule in the name of justice and for good of humanity," which drew the attention of British authorities.

His main weapons were popularity and public fasting. When opposing some injustice, he would simply announce a fast and starve himself nearly to death. Massive public strikes and waves of civil disobedience followed, invariably forcing the government to consider his demands.

Not an outspoken opponent of religion, Gandhi did advocate humanism and total religious tolerance, as well as cast and racial tolerance. He inspired freethinkers and humanists all over the globe, including Bertrand Russell, Einstein and Margaret Sanger.

The Gora family, who worked closely with Gandhi and the nationalist movement for freedom, founded the Atheist Center of India in 1940.

Here's my favorite Gandhi quote: Someone once asked Gandhi what he thought of Western Civilization. His reply: **"I think it would be a** great idea."

Gandhi died in 1948, victim of an assassin. Years of asceticism, fasting and personal neglect, including a lifelong refusal to wear shoes, had rendered him sickly and frail, arthritic, feet calloused, eyes weak, and even his teeth badly decayed. Still he stayed cheerful, optimistic to the end, and spiritual in the humanistic sense.

One might say he was a *super calloused fragile mystic plagued with halitosis*.

Some Gandhi Quotes


My religion is based on truth and non-violence. Truth is my God.
