Sunday, January 9 Against the Immortality of the Soul

The January AOF meeting features Dr. Matt McCormick, member of the Department of Philosophy at California State University Sacramento (CSUS). Dr. McCormick will present an argument undermining the idea of life after death, a notion firmly entrenched in the minds of most Americans.

How entrenched? According to a October 25, 2003 report by Ms. K. Connie Kang of the Los Angeles Times, the Barna Research Group found "76 percent of Americans believe in heaven and 71 percent in hell—same as a decade ago. Among those who believe in heaven, nearly half (46 percent) described it as a "state of eternal"

The AOF Line

On behalf of the AOF board of directors, I would like to wish everyone a happy new year. The new year traditionally affords a time for reflection and resolutions. I would like to encourage everyone to attend the AOF January 9 general meeting as one resolution. The refutation of the human "soul" should prove interesting.

Another good way to start off 2005 -looking at the American Humanist Association (AHA) Grass Roots manual's chapter on "Issue Advocacy."

AOF's main purpose is to serve as a community resource for education on the topics of atheism and atheistic perspectives on separation of church and state. The core issue which binds members of AOF is the belief that both worldview-advocates and government work best when separate.

The AHA recommends a few strategic steps to foster issue advocacy within local grassroots organizations. First, learn what's going on. Second, form coalitions with like-minded groups. Third, act locally. Fourth, form Action Alerts to keep activists notified. Finally, the AHA gives hints on how to get members involved, turn them into activists,

delegating and managing tasks, and creating an inclusive atmosphere.

First, issue advocacy depends on learning what's going on. Many national

organizations track national issues, but many local issues get missed. National organizations simply don't have the resources to track every local issue. So the AHA recommends beginning by establishing small committees to cover specific issue areas and report back to the group. Activities can be issue specific or source specific. E.g., tracking movements in the state legislature or tracking the local religious right activities.

Second, forming coalitions with likeminded organizations helps strengthen the probability that the desired goal will be achieved. The AHA lists a number of coalitions they support, including the Council of Ethics-Based Organizations (CEBO) and the Leadership Conference on Civil Rights (LCCR).

Third, once coalitions have been formed, and group members are tracking what's happening locally, it's a good time for action. The following actions have a positive effect: letter-writing, press conferences, public educational forums, voter registration drives, visits to key representatives, public protests (E.g., candlelight vigils, marches), or any other creative act.

Fourth, action alerts can mobilize members and activists. They inform people about issues they care about so they can raise their voices to be heard.

Finally, the AHA lists a number of suggestions for getting members involved, turning members into activists, delegation and

management of tasks, and creation of an inclusive atmosphere. Every group has a primary core of activists, which form approximately 5-10% of the membership, plus a secondary core

of activists, approximately 10-20% of members, who attend meetings and will volunteer when asked. Delegation and management of tasks is easier when lists are created to note everything which needs to be done. Then tasks can be assigned based on member interest. Creating an inclusive atmosphere can be

with her husband to the Rocklin school district. She, very much pro education, enjoyed volunteering at the school her seven-year old daughter attended.


At school, Rena's daughter encountered some kids who attempted to frighten the child into believing in their Christian God. Their efforts failed, but Rena's daughter—an atheist, did not appreciate the bullying tactics she encountered.


In 2001, about a month after 9-11, Rena drove her daughter to school and saw on the school's marquee, "God Bless America."

For Rena, that was the last straw and she requested the phrase be removed or her daughter would not attend that school. She informed the principal that her daughter nor other students should be forced fed his version of faith.

Rather than keeping the matter private, Rena's name was released to the news media. The majority of the corporate media sided with the message on the marquee. Violent threats arrived on her phone answering machine.

existence in God's presence" and almost a third (30 percent) said heaven is "an actual place of rest and reward where souls go after death." One in eight said heaven is just "symbolic" (14 percent)...."

Just five percent denied a belief in an afterlife. Another five percent didn't feel strongly enough to answer one way or the other.

As for hell—"Four out of 10 (39 percent) believe that hell is "a state of eternal separation from God's presence" and one-third (32 percent) "an actual place of

torment and suffering where people's souls go after death." One in 8 believe that hell is just a symbol of an "unknown bad outcome after death" (13 percent)."

In addition to his teaching responsibilities, Dr. McCormick has also undertaken an advisory role to a new Secular Student Alliance group at Sac State. We commend him for his encouragement of student involvement. Dr. McCormick's talk will be followed by a Q&A session and light refreshments. The public is invited.

The Jews and Secularists Did Not Steal Christmas, but It Was Stolen! By Michael Lerner

Flush from their electoral victories in November, some leaders of the Christian Right have decided to make an issue of the secularization of Christmas. Objecting to the move by Macy's and some other retailers to wish their shoppers "Happy Holidays" or "Seasons Greetings" instead of the traditional Merry Christmas, they have begun to accuse secularists in general, and, on some of the rightwing talk shows, Jews in particular, of undermining Christmas.

It's easy to dismiss these Rightwingers as sore winners. They are well on their way to packing the judiciary with judges who may erode the division between church and state, make abortion more difficult or illegal, and support the pro-torture position of Bush's choice for Attorney General. Yet the 25% of Jews who voted for Bush in this past election may not have imagined that along with his vigorous support for Sharon and for

the war in Iraq, Bush's electoral victory could spur a public assault on the legitimacy of Jewish identity in the U.S.

The assault has been led by Bill O'Reilly, the most popular cable newscaster, who told millions of viewers that there was a systematic assault on Christmas by secularists. When challenged by a Jewish caller who said he felt uncomfortable being subject to frequent attempts to convert him by Christians at his college, O'Reilly responded: "All right. Well, what I'm tellin' you, is I think you're takin' it too seriously. You have a predominantly Christian nation. You have a federal holiday based on the philosopher Jesus. And you don't wanna hear about it? Come on -- if you are really offended, you gotta go to Israel then. I mean because we live in a country founded on Judeo -- and that's your guys' -- Christian, that's my guys' philosophy. But overwhelmingly, America is Christian. And the holiday is a federal holiday honoring the philosopher Jesus. So, you don't wanna hear about it? Impossible. And that is an affront to the majority. You know, the majority can be insulted, too. And

that's what this anti-Christmas thing is all about."

Meanwhile, Richard Viguerie, the master of Right-wing direct mail campaigns, interviewed by Terry Gross on NPR's Fresh Air on Dec. 13, repeated the charge that Christians were the victims of a systematic secularists assault against Christmas. On MSNBC last week William Donahue of the Catholic League insisted, "Hollywood is controlled by secular Jews who hate Christianity in general and Catholicism in particular. It's not a secret, OK? They like to see the public square without nativity scenes."

Liberals and civil libertarians would be making a huge mistake to see this as merely the rantings of a few overt anti-Semites and anti-civil-liberties extremists. They articulate a legitimate concern that many Christians say privately: their children have learned that Christmas is about buying-and the person with the most expensive gifts wins!

There is a beautiful spiritual message underlying Christmas that has universal appeal: the hope that gets

reborn in moments of despair, the light that gets re-lit in the darkest moments of the year, is beautifully symbolized by the story of a child born of a teenage homeless mother who had to give birth in a manger because no one would give her shelter, and escaping the cruelty of Roman imperial rule and its local surrogate Herod who already knew that such a child would grow up to challenge the entire imperialist system. To celebrate that vulnerable child as a symbol of hope that eventually the weak would triumph over the rule of the arrogant and powerful is a spiritual celebration with strong analogies to our Jewish Chanukah celebration which also celebrates the victory of the weak over the powerful. And many other spiritual traditions around the world have similar celebrations at this time of year. The loss of this message, its subversion into a frenetic orgy of consumption, rightly disturbs Christians and other people of faith.

Yet this transformation is not a result of Jewish parents wanting to protect their children from being forced to sing Christmas carols in public school, or secularists sending Seasons Greeting cards. It derives, instead, from the power of the capitalist marketplace,

operating through television, movies and marketers, to drum into everyone's mind the notion that the only way to be a decent human being at this time of year is to buy and buy more. Thus the altruistic instinct to give, which could take the form of giving of our time, our skills, and our loving energies to people we care about, gets transformed and subverted into a competitive frenzy of consumption.

Not surprisingly, the Christian Right is unwilling to challenge the capitalist marketplace-because their uncritical support for corporate power is precisely what they had to offer the Right to become part of the conservative coalition. Their loyalty to conservative capitalist economics trumps for them their commitment to serving God. But for those of us who want to prevent a new surge of anti-Semitism and assaults on the first amendment, our most effective path is to acknowledge what is legitimate in the Christians' concern- and lead it into a powerful spiritual critique of the ethos of selfishness and materialism fostered by our economic arrangements. It's time for our liberal and progressive Christian leaders and neighbors to stand up against on behalf of Jews and on behalf of their own highest spiritual vision--and challenge the real Christmas thieves!
