At AOF's April membership meeting, Darien De Lu will speak on "Faith in the Human Power for Good: The Key to Endurance in Hard Times".

Ms. De Lu - a life-long activist in peace, justice, environmental, and feminist politics - is the former Co-President of US Women's International League for Peace and Freedom (WILPF). She left her Co-President position last August to become the US WILPF representative to the Executive Committee of the *International* WILPF.

The WILPF organization was founded in 1915 at the onset of World War I, still years before American women acquired the right to vote. The impetus for its founding by Jane Addams, a Nobel Laureate, and hundreds of other American and European women, was resistance to what they saw as the white male's irrational hunger for war. It stands today as the world's oldest international secular peace organization.

## The AOF Line

This month's column will focus on the topic of fundraising, from the American Humanist Association's Grassroots Manual (AHAGM). The manual lists broad areas of fundraising: membership dues, fundraising drives, major donors, grants, fundraising events, and forming a development committee.

AOF takes in money primarily from members' tax-deductible donations, membership renewals, sales item purchases, and raffle sales. AOF primarily expends money through its programs and monthly mailings, although we occasionally support events like HeartStrong (<a href="http://www.heartstrong.org/">http://www.heartstrong.org/</a>), and subsidizing the trips of students to attend Atheist Alliance International conventions.

AOF's membership dues structure aligns with the AHAGM recommended policy of more members at lower dues, instead of fewer members at higher dues. The manual recommends setting the dues lower and asking for more money after the renewal date.

The AHAGM is very blunt about the purpose of fundraising drives (appeal mailings) – "they are the key to making-up the difference between what your membership dues raise and

what you need to meet your basic needs."

Recommended levels of special appeals per year are at least two. Some ideas: create a fundraising drive to benefit children and students in the

group. Also, ask for higher contributions, and vary the appeals to see what works.

With respect to major donors, the AHAGM suggests that while fundraising drives can make up the difference between membership dues and what the group needs to meet basic needs, "major donations can help the group expand programs to reach

the true potential." To define how much a major donation would be for AOF, the AHAGM suggests taking the top 10 donors, and using the smallest donation as the cut-off point for a major donation. It also lists a number of strategies for contacting and asking for money, and how to reward major donors through special events.

Grants constitute another potential source of income. Sources for grants include the AHA, the Institute for Humanist Studies, and institutions listed in the "Foundation Directory" at the local library. The AHAGM lists three similarities to all grant proposals: Applications, Time lines, and Contacts.

Fundraising events are the fourth type of fundraising source. The AHAGM warns risks may outweigh the benefits -- although if successful, the event can be a source of significant income. Events are typically labor intensive, and incur costs for food, facility, entertainment, and invites. It recommends low donor events (e.g., bake sales) as a more appropriate form of fundraising, getting people involved, and recruiting volunteers.

Finally, forming a development committee with leaders who can talk readily about the strengths of an

organization will go a long way toward "soliciting for grants, donations, holding house parties, identifying large donors, and/or sponsoring events." The finance chair will work with the

committee to develop the budget and fundraising plan.

Do these ideas for fundraising get your brain humming? Would you like to get involved with helping AOF raise money? We surely would love to work with you! Let us know if you are willing and able to help out. See you next month!

# Review of a Dramatic Presentation Paul Hauk Does Clarence Darrow By Hank Kocol

On Sunday, March 13, lucky AOFers who attended the monthly meeting at Sierra II Community Center were regaled by a very intriguing presentation.

Mr. Paul Hauck brought to life probably the best-known "people's attorney" of the early 20th century, Clarence Darrow. Mr. Hauck derived his characterization of Darrow from the writings and speeches of that attorney. His portrayal was set realistically in the milieu of the American society of those times.

Probably the most famous case tried by Mr. Darrow was that of John Scopes, the science teacher from Rhea County High School in Dayton, Tennessee. Mr. Scopes was tried for the teaching of evolution, a crime under Tennessee state law at the time.

Mr. Hauck portrayed Darrow's attempts to get testimony from several expert scientific witnesses, all attempts denied by the court since the judge had determined that the issue was not the truth of evolution but the question of whether state law was in fact violated. As those of us who read the book and/or

watched the movie "Inherit the Wind" know, Mr. Darrow took advantage of the arrogance of the prosecuting attorney, William Jennings Bryan, in allowing himself to be questioned concerning the biblical story of creation. As we also know, Mr. Scopes was found guilty and ordered to pay a fine of one hundred dollars.

We were also reminded that Mr. Darrow was involved in many of the social issues of the day, such as free speech, worker rights, issues of the rich versus the poor, and capital punishment, such as the Leopold-Loeb murder case.

The acting ability of Mr. Hauck was flawless, making the audience ready to believe that we had really seen and heard Clarence Darrow. The depth of the research he did in order to portray the character and events was very evident in the show.

This meeting was another reminder that we should all try our best to attend AOF meetings. The Program Committee is to be lauded for its fine job in obtaining speakers for our group.

## Brief Play Recap By Dave Flanders



For the March AOF meeting, actor Paul Hauck performed his play "The Trials of Clarence Darrow." Paul began by taking on Darrow's character and recounting his early days as a lawyer. He spoke of the injustice of the Pullman railroad company—how management exploited the workers and how it propelled him into a career defending the working man against the corporations. Here are a few highlights portrayed during the afternoon.

- Darrow fought for labor rights of coal miners who wanted an 8 hour work day and wanted to make more than starvation wages. He achieved success in helping them get an eight hour day.
- He defended activist Bill Haywood. Clarence saw him as a foe of corporate power and helped Bill get acquitted.

## Paul Hauck, Actor

Paul's first stage experience was in high school. He was cast as Murray in A Thousand Clowns - mostly because he was the only boy willing to appear on stage in his underwear.

After a thirty year hiatus to pursue a career and raise a family, he returned to community theater as Elwood P. Dowd in Harvey with the St. Michael's Actors Guild.

In the intervening five years he has been seen with the T Street Players in such roles as Scrooge in A Christmas Carol, Prof. Von Helsing in

Dracula, Mr. Green in Visiting Mr. Green, John Ruffing in Ravenscroft, and most recently as Nick Flanagan in *The* Guys.

Paul returned to St. Michael's to play Detective Trotter in *Mousetrap* and Samuel in *The Curious* Savage. He has also appeared as Porter Milgram in the Main Street Theater Works production of Deathtrap. This is Paul's first attempt at writing for the stage. In his spare time Paul works as

a child clinical psychologist and maintains a vintage thirty-three year marriage.

- Over the years, fighting the oppressive corporations wore him down. Workers all over America considered Clarence Darrow to be their hero.
- Later, Clarence was charged with bribing two jurists. He was acquitted. He told the prosecutor that if he was thrown in jail, 10,000 more men more eloquent than he will continue the fight for the little guy and/or woman.
- Darrow then defended biology teacher, John Scopes. Clarence recounted that the judge forbade any scientist to testify. Due to the celebrated anti intellectualism that he experienced at that trial, he was not surprised that he lost that case.
- He defended Dr. Sweet--a black doctor who experienced threats when he attempted to move into a white neighborhood. A racist crowd threatened the family, throwing rocks at the house. A white man was shot. Sweet was accused of killing the white man. At first Sweet was found guilty; the second time he was acquitted.

During the question and answer period, Paul commented that much of what Clarence fought in his day resonates yet today--racism, worker exploitation, etc. Paul said he edited the dialogue to present the legal and sometimes shady side of Clarence Darrow. It appeared that everyone at the meeting thoroughly enjoyed both the play and the question and answer period.

## Paul Hauck, Author (Play Notes)

I can still remember being a young boy and being excited when I would read in the TV Guide that "Inherit the Wind" would be on. I can still see Spencer Tracy taunting Fredric March with "Brady, Brady, Brady!" as he paced the courtroom on our black and white set. That image returned frequently as I worked on this script. But my reading of Darrow's life and work revealed a far more complex figure – greater and more flawed – than the theatrical, somewhat cynical character Tracy portrayed.

I hope that in this telling I have captured some of the development of this man - this paradox. An atheist who one jurist described as "the most Christ-like man I have ever known." A man who saw injustice so clearly yet could lose his way so utterly.

As I have lived with the stories of this man's life I have been awed at the resonance of the issues of his era and ours. The continuous tension between labor and management as they compete for resources. The relationship of industrial wealth and government power. The constant effects of racism. The struggle to protect individual rights when national security is threatened. The debate over what our children should be taught in school and how society should respond to the perpetrators of the most unspeakable crimes.

I hope this play in some small measure serves to further Darrow's goals; in his words: "to improve human understanding, to temper justice with mercy, to overcome hate with love."

It was unfortunate that space limitations in our March newsletter prevented our including the above information on Paul Hauck (and by Paul Hauck) prior to his presentation. He will perform the material again for the Sun City Humanists in Roseville on Sunday, June 5 (1 PM). After nearly forty years as an activist and organizer, Ms. De Lu has had ample experience with the necessity of endurance in the face of political setbacks. However, WILPF has shown even greater endurance through its mission of "eliminating war and the causes of war": this year WILPF groups in over 40 countries will celebrate WILPF's 90th anniversary.

In addition to honoring 90 years of commitment, US WILPF will focus on Middle-East peacemaking and global water politics at the national triennial Congress in San Francisco this summer. (All like-minded people are invited to the Congress, August 10-14 at California State University, San Francisco.)

Ms. De Lu will use song as well as more traditional speech to elaborate on the her theme of faith in the potentials of humanity (along with enjoyment of life!) as a foundation to political perseverance.

event included world-renowned evolutionary biologist Richard Dawkins, who outlined the concepts he plans for his next book and presented an award to media celebrities (and atheists) Penn & Teller for their outstanding work in the cause of atheism. Andrew Bradley, who created the humorous website "Betty Bowers, America's Best Christian" was just hilarious, as was Michael Newdow, who regaled the audience with an American history summary in which almost every word he used began with the letter, "c".

Dr. Bruce Flamm, who was quoted in *Time* magazine as the man whose persistent inquiry proved the Korean-Columbia University prayer fertility study to be fatally flawed, described his challenge and the stonewalling of both the University's Medical School and the *Journal of Reproductive Medicine*. 
## 2005-6 Nominations Committee Report
