

Just prior to this move, I became a "guide" for About.com. They had all kinds of sites on religion, but none on non-religion. I had to threaten them with discrimination before they created an Agnosticism/Atheism site. I

was the site's first guide, but was replaced due to my long offline period during the move.

In case you had any doubts, Utah is not the most atheist-tolerant state in the nation. Not long after moving there, I began to write letters to the

Did You Know? By Cleo Kocol



Most of us grow up knowing Percy Bysshe Shelley was a poet admired for his imagery, subtle melodies and inspired lyrics, but did you know that he was a vehemently outspoken critic of Christianity?

Recently four letters he wrote in 1810 were found in the home of two London brothers who died last year. The letters are to be auctioned at Christie's International and are expected to bring up to \$58,000. The letters were the forerunners of his pamphlet, "The Necessity of Atheism." They created a scandal in Britain and led to Shelley being ousted from Oxford in 1811.

Another interesting sidelight, his mother-in-law was Mary Wollstonecraft, famous for writing "The Vindication of the Rights of Women." Her daughter, Mary, Shelley's wife, garnered fame by writing "Frankenstein."

The End of Faith

Book Review by Steve Knapp



The End Of Faith - Religion, Terror, and the Future of Reason, by Sam Harris (2004, Norton, New York).

One of the lesser known consequences of the 9-11 terrorist attack is a scholarly investigation into the causes of terrorism by a philosophy graduate from Stanford, one Sam Harris. That investigation resulted in this book, which discusses at length the dangers to human societies presented by many of the major religions, especially those that are monotheistic and paternalistic.

To his great credit, Harris pulls no punches. In the first two thirds of the book, he examines the degree to which most religions are irrational and based on arbitrary and false assertions. While showing that we humans usually depend on the facts and observations in our everyday lives, Harris demonstrates that the great religions are so intrenched in our cultures that their scientific falsehoods and irrationality are never questioned or criticized.

He discusses the basis of religion primarily in terms of the superstitious need commonly felt by members of our species to seek an afterlife and to explain seemingly random events, including those that are good, like winning the lottery or finding a parking space. I have to admit that with the current Bush administration I find myself looking desperately for something better! While there may be an innate fear

of dying, I personally found this explanation of religion insufficient and would like to see something about our "hardware".

For example, I think that religions exist in part to promote the propagation of each person's DNA, a process seen in other species. Religions provide for controlling the sexual lives (e.g. insemination) of the women, and the more fundamental the religious sect, the stronger the power, control, and paternalism. I note that tribal or cultural warfare, also strongly associated with competing religions, is another form of control of reproduction because such warfare is really to determine which set of males gets to impregnate the women.

Women, of course, are considered as property by the men. To allow any form of autonomy or sexual tolerance (be it over womens' rights, reproductive choice, or sexual orientation, etc.) necessarily implies the capitulation of the power and control over the (personal, family, tribal) DNA. This is explains the brutal family law found in the bible and koran and other fundamental texts, and the strong hierarchical power structures promoted therein.

Harris devotes several chapters to citations from the Koran, Bible, and other "holy" books, with extensive discussions of not only how violent the consequences can be but also of how the respective cultures tolerate religious aggression and turn it into violence.

One of the delights of the book is Harris' clever and sardonic prose, with which he demolishes the concept of the religions being loving or good, particularly with respect to the intolerance of, and violence toward, competing theologies, which after all, was the motivation for nine-eleven.

The final chapters of the book contain extensive philosophical discussions of the nature of the human and what it means to be conscious, for example. Frankly, I get bored by the analysis of perception and thought, if there is any. But in the end, Harris quite correctly asserts that the only solution to the dangers of religions is objective facts, i.e., the products of science, which may of course have agitated the fundamentalists into extremes of aggression of late. The truth shall set you free, and it damn well better hurry up.

The Very Best, and the Very Bad

The Sea Within and Heart of the Beholder

When a movie is written, directed, and produced by the same person, that person had better be Woody Allen. It takes great talent to do any *one* of those motion picture tasks well. Only someone extremely talented can do *all three*.

The situation becomes worse when all three are attempted by an amateur. *Heart of the Beholder* was done by an amateur and, in short, the movie is a disaster (mind you, I am comparing it with theater films, not TV movies, since I don't have a TV).

The story is based on how Ken Tipton, the aforementioned amateur, lost his family, multi-million dollar video store chain, and his way of life. Christian Citizens for Decency had implemented a boycott to remove videos deemed pornographic from his shops. His shops were closed and then sold.

The movie's first hint of disaster was the opening screen which stated, "Based on a true story." That phrase generally sends me running out of the theatre. But just two days before viewing *Beholder*, I had viewed a "based on a true story" film which was about the best film I had seen in a very long time — *The Sea Within.* (*The Sea*'s director, editor, composer (music score), producer, and screenwriter is Alejandro Amenábar.) I was staggered by how well a movie can be constructed.

The Sea Within is, in my opinion, the best film providing a truly secular approach to living and dying ever produced. When you view the DVD of The Sea, do not skip the two commentaries on the film. They are the best commentaries I have ever seen on how a film gets produced.

Back to *Heart*.

Tipton's script shows no signs of anything except black and white characterizations. The bad guys are all malevolent, plotting, ranting Christians, and a totally corrupt prosecuting attorney. The good guys are a hard working entrepreneur, a loving and supportive wife, a cute kid, an honest cop, and a chipper employee. Nobody bad does anything good, and nobody good does anything bad. The whole thing comes down to a metaphoric paint ball war between the protagonist and the bad guys. As if one should cower in abject fear when faced by a paint ball. Tipton's directing is tolerable at best.

The strongest aspect of the film was the acting. The actors, across the board, did a fine job with the script they had. George Mooradian's photography was quite adequate.

editor of the local paper, virtually a lone voice to counter the idiocy spouted in those pages. In 30 months there, I had over 50 letters published. Quite a trick, since they had a limit of one letter per person per month and verified every letter published. (The trick was to publish some in my wife's name, and others

under the name of a fictitious "cousin" who happened to live with us, and had his own phone number... that number being my cell phone.)

I also started the Freethought Society of Northern Utah, which grew to about 75 members in 18 months. We even got on the front page of the local paper

within sixty days of our inception, challenging a county clerk who insisted on imposing her religious beliefs on those who came to her for a secular marriage ceremony.

It was during those days that I began work on my novel, *One Nation Under God*. For information, go to (http://www.onenationundergod.info)

I humbly consider it not only a good story and a great exercise in experimental storytelling, but also a primer for non-theists to use in their "battles" against the forces of theism. I drew heavily from my own encounters with Creationists and others for much of the story.

I was thrilled that Dan Barker of the Freedom from Religion Foundation (I'm a member of nearly a decade) gave an endorsement blurb for

> the book, as did our own Paul Geisert and Mynga Futrell.

"ONUG" (horrible acronym) is my second published novel, and a third is in the works.

I also currently serve as Vice President of Northern California Publishers & Authors, and teach a series of fiction writing courses

for The Learning Exchange. And somewhere in there, I manage to work full-time for the California Hospital Association, supporting two VPs.


