AOF to Update Its Amicus Brief

"... under God" Pledge Suit Two By Mynga Futrell

Michael Newdow has asked if AOF would consider preparing another amicus curiae brief, this time for his renewed pledge case. At the June board meeting, AOF's board voted unanimously to do so!

Mike's "infamous" prior case sought removal of the words "under God" from the text of the official pledge. The Elk Grove School District appealed his previous Ninth District "win" and went all the way to the Supreme Court. There, the Supremes ducked the issue, determining that Mike did not have standing to bring suit in the first place. This time, however, there are no questions but that the current plaintiffs clearly qualify to bring the case. And, the new Pledge of Allegiance

Regional Atheist Meeting

AOF LineBy Don Knutson

San Francisco Atheists hosted the first West Coast Regional Atheist Meet on Saturday, June 24 at Crowne Plaza Hotel in Foster City. SFA is a principal member of American Atheists, Madalyn Murray-O'Hair's organization. founded in 1963 after O'Hair sued to remove the daily prayer from the public school classroom. AOF is an affiliate of AA. The Meet attracted 152 attendees creating complications for the organizers since they had anticipated only 100. But given the quality of speakers, the delay at the beginning could be forgiven.

Ellen Johnson, AA President, opened the one-day convention by inviting everyone to visit their New Jersey headquarters where AA has

assembled an atheist historic library. She also emphasized the need to "vote atheism regardless of party.

"Richard Carrier, David Eller and Eddie Tabash were among the speakers

at the event. Tabash, a Hollywood constitutional lawyer, focused on "divine hidness," meaning that a shy deity does not do anybody any good. Eller, whose film we viewed at the June AOF meeting, brought language to the fore in his talk and demonstrated how it can be

used to make religion and the corresponding deity "seem real." He said that framing the language we use in communicating with evangelists can reclaim the context. Therefore, he suggested not using particular words and substituting them with others accordingly. Instead of "spirit," "emotion" or "feeling" could be used. "Belief" would be replaced by "unsupported claim", "religion" by "religions" or "system of unsupported claims", "church" by "churches" or "holders of unsupported claims" and "Bible" by "Judeo-Christian writing". Avoiding the pitfalls of common language can remove the evangelist from his comfort zone.

The program concluded with a panel

including Carrier, which made fun of the various theories of the existence of Jesus given the social hysteria aroused by "The DaVinci Code". This aspect of the conference

served to highlight the differences between AA and Atheists Alliance International. AA loves to savage religious beliefs for fun and mayhem while the latter chooses to address our differences with religions in a more respectful manner.

Meeting Recap Natural Atheism By Dave Flanders

At our June meeting, Larry Hicok, Coordinator of East Bay Atheists, presented a video about natural Atheism featuring David Eller, to AOFers. In the video, David spoke about his book "Natural Atheism."

According to Eller, the brain uses vast amounts of memory to create a model of the world. Small children imitate the models they observe in their childhood. In David's' case, his parents did not compel him to follow a particular religion, thus he grew up a natural atheist. He considers atheism more than a nonreligion; it is an affirmative stance, a condition of intellectual, personal and moral freedom. In the same way, health is not just the absence of disease nor peace just the absence of war, but health and peace are positive conditions of strength. or well being, of ability to do things and to live and enjoy your life. So atheism is a psychological and existential condition of strength and well-being and ability to live and enjoy life, use your mind and trust yourself.

The book includes a 12-step program for atheist. The first step states that the party (the theist in this case) who makes a claim has

the burden of proof, not the party who questions the claim. The other steps provide arguments that, when followed, help one-step into a world without gods - the only world there is.

Many anthropologists understand that culture is like a pair of glasses in that it shapes how we see the world and therefore how we interact with it. Even what we think or expect is actually present in it. As with glasses, people do not ordinarily see their cultures, but rather they see through, via, or by means of them, seeing the world as the culture so distorts it. Anthropology, in this analogy, becomes the means to not only see the cultural glasses of other people and societies but attempt to try those glasses on and 'see' or think or understand as those others do. Ultimately, it forces us to realize that we, too, wear cultural glasses that can with great effort, be removed and replaced with other glasses.

One of the main obstacles to freethought is the certainty in one's own truth and goodness, the kind of 'one possibility thinking' that is characteristic of all traditional and most modern societies. Both anthropology

and the movements for freethought that preceded it sprang from the same sources, namely, the acceptance of Otherness and the awareness that differences in value, morality, and 'truth' are real and are not going away. Both freethought and anthropology are symptoms of the same underlying condition--the relative condition, the condition of difference. Societies that do not acknowledge or appreciate the possibility of difference, although they may be surrounded by it, will not develop anthropology, and they will not develop freethought. Both anthropology and freethought are products of living with one foot outside of one's own social reality.

Eller prefers the phrase "separation of churches and state" to "separation of church and state," stating there is no such thing as a singular church in the real world. Instead, there are churches, gods, religions, etc.. Moreover, if a theocracy was established, which church would be established and which not tolerated? Other topics were covered. Questions and snacks followed the video.

Book Review: The Great Mortality: An Intimate History of the Black Plague

By John Kelley, Harper Perennial, 2006, 400 pages.

What was the worst disaster ever to befall humankind – World War II, Maoism, Stalinism, the fall of the Roman Empire, the Dark Ages, the Church? Not close. In terms of economic loss, cultural chaos and raw body count, it was the Black Death, which raged across Europe from 1347 to 1352, killing up to 60% of the population. In *The Great Mortality*, John Kelly chronicles its grim surge and ebb, how it began, the scars it left, and what it must have been like to live while the world was ending.

The Plague took three forms: Bubonic, Pneumonic and Septicemic – the last was worst, often killing within hours. It began in Mongolia, or perhaps northern China. A climate shift encouraged a population boom of marmots, and new trade routes invited the bacteria (*Y. pestis*) to make a leap to people. A tendril drifted to Crimea, leapt to Constantinople, then to Sicily, Italy and Spain; from there it metastasized

madly across Europe, raging as far as Iceland and Norway, everywhere killing, killing, killing, then fading back a bit, rising and killing again, before sauntering off at last, sated, into the Russian steppes (but revisiting well into the 1600's).

Here in our soft chairs, armed with some knowledge of sanitation, antibiotics and vaccines, the horror of it is hard to imagine. But think of villages and cities depopulated, carts piled with stinking bodies, mass graves, "death ships" manned by corpses crashing into ports (and imagine black waves of diseased rats boiling off those ships, drooling bloody froth, a death warrant for the city). Think of panics, purges and pogroms, anti-Semitic riots kindled by rumors of poisoned wells. And the worst aspect was fear of helping the sick – even touching a victim's clothing could be fatal. So families deserted their own fathers, mothers, children. Those who

stayed with loved ones were often sealed within their houses, healthy and sick alike, a communal death sentence.

The story sprawls larger than life, full of petty gestures and heroism, cowardice and courage, and horror in lapidary detail. For freethinkers, a fascinating aspect is the hairline cracks left in religious devotion, as people realized, eventually, that prayers and supplications were useless, and the clergy seemed even more susceptible than laymen. So the Plague may have planted a seed of the Renaissance, a century later.

The Great Mortality is a great read. Recommended – if you are feeling well.

complaint will benefit from "lessons learned" in the previous experience. Readers of AOF News & Views may recall that AOF's prior brief was written in a whirlwind. It probably holds the world's record of time from first keystroke to application of the postage stamps. Paul Geisert and I wrote it in an almost round the clock endeavor, starting immediately after Mike told us that it would be a good thing to have. (He had been relying on another source that fell through.)

Trouble was, it was the last week before all materials were due. Thus, the project began on a Monday and culminated that same Friday! We had on hand as raw material a pile of supportive letters from parents and children and citizens that had been received by us. These we culled for quotes that could best "bring home" to the justices the classroom situations that harm children. All continue to hold true and can be used for the current case, which Beverly Church has volunteered to "shepherd to completion" since we are in Europe at the moment.

We have provided Bev with the formatted text of the original amicus, so she can update it to match the current case, and perhaps to incorporate some additional material that has been received in the interim. The gist of AOF's new brief will be the same, though.

Two years have passed and more children across the nation have experienced in their classrooms the so-called "unifying" ritual that requires acknowledgement of God in order to express patriotism. Some of these youngsters immersed in pledge exercises have undergone far more than the stresses of thinking differently. There are sometimes cruel consequences of "opting out." These make all too clear how the "nation, under God, indivisible" divides by religion.

AAI Earns Its "I" for "International"

"Top of the World" Atheist Alliance Conference

I want to report my personal delight in having had the marvelous opportunity to set foot in the "Land of Fire and Ice" and attend the very first international conference to take place under the imprimatur of the Atheist Alliance. (Every prior formal AAI gathering has been in the United States.

It was not only the presence in Reykjavik of AAI board representatives from several countries (Canada, Denmark, Germany) in addition those from the United States and host nation Iceland that showed that AAI was beginning to be deserving of the "international" in its name. There was the additional fact that attendees had come from so many different places to hear the speakers and taste the warm hospitality of the Icelanders. As might be expected, most who traveled here were Americans, but several came from nearby spots in

the U.K. and Scandinavia. Persons from far across the planet (e.g., "down under" Australia) sent greetings and messages.

The conference was titled "A Positive Voice for Atheism in Iceland," and Paul Geisert and I saw ourselves as highly fortunate to share the program with many speakers of note (Dan Barker, Richard Dawkins, Margaret Downey, Annie Laurie Gaylor, Hemant Mehta, and the delightful Julia Sweeney). Though we were clearly invited there due to our work with the network of Brights, our presentation was broader. We focused on activism, and in keeping with the conference theme, we titled it "Seizing the Elusive Positives."

AOF played a prominent role in our presentation, which outlined some of what we learned from our activism experiences that led up to the particular proposals for activism we

were recommending. AOF was the centerpiece of Part 1 (the notion of a "positive atheist" group) in a three-part segment.

Besides the conference itself, the most exciting highlight has been traveling out of Reykjavik to view the volcano-produced Icelandic landscape and having had an opportunity to "step to both sides" of the fault that is the dividing line between Europe and North America. The landscape along the fault-line is simply stunning and (on a day when Sacramento reported above 100 degrees) the breeze more brisk than biting.

As I am traveling at the moment, readers of AOF News & Views can expect a fuller report of conference events at a later date, but right now I'm just "flying high" from having been to what Iceland's tourist bureau touts as the "Top of the World."
