Those who attend AOF's September general meeting will be hearing from Parvin Darabi on the topic, "Women and Islam." The speaker, who was born in Tehran, has been interviewed by numerous newspapers, radio and television stations on the oppressive conditions faced by women, religious minorities, and political dissidents of Islam and Iran. This is a very pertinent topic for today's world, so we hope to see many AOFers at the meeting.

Ms. Darabi will be traveling to Sacramento from Truckee, where she directs the Dr. Homa Darabi Foundation. The Foundation is named for Parvin's sister Homa, a medical doctor who ended her own life protesting the oppression of women of Iran. On February 21, 1994, Homa set herself on fire in a crowded square in northern Tehran, crying: "Death to Tyranny. Long Live Liberty. Long Live Iran."

Stunned by her sister's death, Parvin left her prior profession as a consulting engineer and dedicated her life to the betterment of women's life in the Islamic world. She and her son wrote a biography of Homa entitled, Rage Against the Veil: The Courageous Life and Death of an Islamic Dissident. The book was published in

# From China To Freethought By Don Knutson

As I mentioned in last month's column, I found in my recent trip to China that the Communist Party had profoundly relaxed its prohibition on established religion since Mao's reign provided, of course, that the worshiper worshipped within the context of the accepted religions of Buddhism, Taoism, Islam, Catholicism and Protestantism

To be frank, this really is not dramatically different from the status quo the Freethought community faces in this country. Of course, the First Amend-

ment prohibits the government's establishment of a religion and the persecution of particular religions but it is quite clear in American society that there are consequences for those wandering outside the realm of the Judeo-Christian tradition.

Take the well-publicized recent firing of Tom Cruise by Paramount, for instance. The superstar actor had been a bit too smug and proud of his Church of Scientology teachings, particularly in his rejection of the legitimacy of psychiatry, as he made the rounds promoting his "Mission Impos-

sible III" movie release earlier this year. As a result, the movie only realized about \$300 million domestically, just a fraction of the take of each of its two predecessors. Therefore, he strayed outside the realm of "normalcy" and paid

the price of rejection from a significant percentage of the movie-going public. This is just another chilling reminder for those of us in the Freethought community who may wander too far from normalcy in our disbelief here in American society.

# Meeting Recap Small Crowd Still Sizzles By Mynga Futrell

Persons who attended the August "Summer Sizzler" found plenty going on. There was a beautiful "spread" of items for the silent auction, and the salad potluck "spread" was equally diverse. The awards program (see separate article) pointed out some of the movers and shakers behind AOF, and then there was the annual "oratory contest" as well. Quite a potpourri!

After the awards and the meal, a series of speakers took to the lectern to mete out their "wisdom" and vie for the "prizes" (a "silvery" cup, and a button that said, "I think, therefore I'm dangerous.") It should be pointed out here that, actually, speakers earn raffle tickets for each minute of *speaking within the set time limit* for their category (2 or 5 minutes). Only speakers can enter the drawing. **Allan Demo** and **Cleo Kocol** were the lucky winners at

this year's program. For those who missed it, here's a brief glimpse of the offerings.

**Cleo** kicked off the five-minute entries with a segment on Elizabeth Cady Stanton in acknowledgment of the forthcoming August 26 parade event commemorating the march for suffrage. Mynga Futrell followed with "Bragging on AOF," a short piece excerpted from the full presentation on positive atheist activism she had delivered at the AAI conference in Iceland in June. Drawing from her prior experiences, Liz Purcell ruminated with lucidity on the meaning of "Freedom of Thought." Mei Lin Chu concluded the program by describing some of her experiences traveling in different places. Those vivid descriptions of traveling as a woman alone in Afghanistan (which she loved) and Pakistan (which she didn't) concluded the program. Interspersed were two-minute commentaries by Allan ("Playing God") and **Don Knutson** ("The Naxi People").

AOF having moved its silent auction from springtime to mid-August may not have been a good idea, as this meeting drew a much smaller set of "shoppers" than in past years.

Last year's auction was in May, and it brought in \$400 for the Children's Receiving Home of Sacramento, whereas this year's topped out at just \$175. Four hundred dollars had been committed in advance to Camp Quest West as AOF's support for CQW's inaugural season, and so the expected income to recoup the treasury was as absent as the oftannounced forthcoming return of Jesus.

# **Alliance Elects New President**

The Atheist Alliance International (AAI), of which AOF is one of the forty-four member societies in the United States and ten in other countries, announced on August 27, 2006 that its board has unanimously elected a new president, Margaret Downey, from Pocopson, Pennsylvania. She replaces Bobbie Kirkhart, who had served as president since 2002.

Downey has been a First Amendment activist for over twenty years. She is founder and president of the Freethought Society of Greater Philadelphia and the Atheist Anti-Discrimination Support Network, a national watchdog committee that works to protect freedom of conscience.

In assuming the presidency of AAI, Downey said her goal is to help build a strong coalition of Freethought organizations into an effective national voice for an inclusive society. "This nation was founded with the hope and expectation of creating one nation, indivisible, with liberty and justice for all," Downey said. "That goal can be realized only if all citizens are treated equally before the law, with no governmental preference shown for skin color, national origin, age, gender or religious opinion," Downey stated.

Downey has a long record of advocacy as well as litigation to establish the civil rights and civil liberties of nontheists citizens. She has been most persistent in opposing government support for the Boy Scouts of America, due to its discriminatory exclusion of Atheists and gays from membership, and has been a continuing voice in defending the First Amendment against government promotion of religious phrases, mottos and icons.

She has served as an Atheist community expert for two conferences of the United Nations Freedom of Religion or Belief Committee

AAI, founded in 1991, is an umbrella

organization for local, autonomous, religion-free groups, as well as individual members. Its purposes are to help establish and strengthen the religion-free community at the grassroots level and to achieve visibility and acceptance for Atheists as respected contributors to discussions of public policy.
