## *Sunday, January 14* **Religion in the Public Schools: A New Year's Resolution To Support Freedom of Conscience**

**Susan Mogull**, Sacramento Chapter President of Americans United for Separation of Church and State, will speak on the topic of "**Religion and the Public Schools — A New Year's Resolution To Support Freedom of Conscience.**"

Ms. Mogull's talk will focus on proselytizing, praying, the pledge of allegiance, religious clubs, celebrating, and studying about religion. What is the role of the public school regarding these activities? How do the free exercise rights of students and the no establishment responsibilities of school personnel intersect?

## **Renowned Marine Ecologist to be Sacramento's Darwin Day Speaker by Mynga Futrell**

*"I knew what I wanted to be (in life) when I was ten years old. I wanted to be a conchologist, then a biologist, in any case a scientist who does research and who gets to go to all sorts of interesting places."*

These are the words of **Geerat J. Vermeij** who, although blind since the age of three, has seen his childhood dream born out in his career

and life experiences. Dr. Vermeij did in fact become a biologist. He became an intrepid field naturalist who has explored coasts on nearly every continent. Currently Distinguished Professor of Marine Ecology and Paleoecology at the University of California-Davis, Dr. Vermeij is

Given an award at the AAI conference in Sacramento in the year 2000 for her activism, she's never rested on her laurels. She reads many freethought newsletters (including AOF's) looking for activities she can incorporate in the atheist group of which she's a founding member. A resident of Port Angeles, Washington, she's been recognized regionally and nationally by FFRF and has attended many AHA conferences where she always identified herself as a radical feminist. In Port Angeles she started a group she named The Wavemakers, worked hard for the Equal Rights Amendment, was a proud member of NOW as well as the League of Women Voters. She still takes part in International Women's Day events, is interviewed by local media, and has letters to the editor in the local papers.

# Children's Receiving Home

Claire Spear serves as Development Officer for the Children's Receiving Home of Sacramento, where up to 98 children are sheltered each day.

The Home serves as the safety net for the area's abused and neglected children between the ages of 1 and 17. As the only emergency shelter of its kind in Sacramento County, in effect; the Home acts as the front door of the child protective system.

Ms. Spear shared stories of the children she has met during her tenure at the Home. In one case from many years ago, two sisters escaped their environment of physical abuse by running away. Desperate, they turned to a police officer who initially contemplated returning the children to their home. In reaction to their out-

bursts, the police officer ultimately placed the children in the Home. Both sisters now lead stable lives. Awareness of physical violence among police has since improved.

I'd like to continue on the AOF board and play an active role in both organizations as an enthusiastic freethinker.

### Kay Dickey

Kay Dickey has served on AOF's board, holding various offices, during most of the past twelve years. She took the last year and a half off, but feels she is ready to run for the board again in January. She also serves as AOF's co-representative, along with Mynga Futrell, to the Atheist Alliance International (AAI) board of directors and was elected AAI's treasurer in the spring of 2006. She enjoys being part of the decision making process which goes on at the AOF board meetings and serving on various committees.

### Mynga Futrell [Incumbent]

A founding member of AOF, I have served in a wide variety of capacities across the years, including president for two years and editor of AOF News & Views for several. AOF must become more vibrant as an organization and better serve members' needs. I'm dedicated to helping our fellow citizens better understand people like us who have a worldview free of supernatural forces and entities (such as deities). AOFers must work in constructive ways to be seen as moral individuals deserving of a role in society,

and I'd like to help us to do so in Sacramento.

### Don Knutson [Incumbent]

I have been an active AOF member for 12 years and our President for the last two years. I also coordinate AOF's Adopt-A-Highway program. ### Jerry Sloan

Jerry Sloan, 69, is a charter member of AOF and has served previously on the board. My goal is to find us a larger meeting hall so we can grow.

the speaker for Sacramento's 2007 Darwin Day educational gala on Sunday, February 11.

As a scientist, Vermeij uses his sense of touch to study the shape and surface features of shells, and in doing so throughout his long career, he has overcome the formidable obstacle of blindness to become a preeminent evolutionary biologist. In 1992, Vermeij won a MacArthur Fellowship. His remarkable career has been described in numerous places. At the PBS website section on "Scientists," one can read about some of his achievements and how much he has learned through an acute sense of touch. One segment there concludes: "Vermeij probably knows more about mollusks and their shells than anyone alive."


Geerat Vermeij has described his own career studying shells (and the fossil and living animals responsible for building them) in his autobiography, entitled *Privileged Hands: A Scientific Life*. He has published over a hundred scholarly papers and three other books, including *Evolution and Escalation: An Ecological History of Life* and *A Natural History of Shells*. He served as editor for *Evolution*, the field's foremost journal. He has a world-class collection of shells, too.

I met Dr. Vermeij and his wife in Florida in November 2005, where he was invited guest at an anniversary celebration event at "The Shell Museum" on Sanibel Island, a US coastline location long considered one of the world's best shell-collecting areas. (Paul and I had just *perchance* attended that event.) I was delighted to discover there an eminent scientist actually located so close to Sacramento! And, with such an inspiring career story, what a marvelous resource - someone to motivate teachers and students of science as well as to educate us all!

Please mark your calendars for February 11, 2-4:30 PM, and plan to attend **Sacramento's Tenth Annual Darwin Day** (\$10 adults; \$5 students). The location will be La Sierra Community Center (John Smith Hall) in Carmichael. AOF members will receive a special mailing with advance purchase ticket reservation information for this event. *Look for it to arrive in the early part of January.* We look forward to seeing you there! Dignity and intelligence sparked from her eyes in a photograph accompanying a September 22 interview by Peninsula Daily News following a 100th birthday party attended by 100 friends, admirers and family. Following are quotes from the article.

"Monuments to war are plentiful, but none to peace," she wrote in a recent letter to the editor. She's active in the local peace group.

Born in 1906, she remembers when women had no vote and few other rights. When universal suffrage was adopted in 1920, she said her mother "hitched up her little mare to her buggy and went to the polling place to cast her ballot. She always voted, never missing an election." She says she owes her longevity to her genes, having had a relative who lived to 110.

Regarding population, she said, "I have no wish to swell the population." A great grandmother to eighteen, she is passionate about abortion rights, militant about women's rights and peace, and outspoken about her philosophical beliefs. Asked to speak about humanism at a high school class, she explained to the Peninsula Daily News, "They didn't ask me back. I think it was because of the parents who objected to my being an atheist."

A story-teller, she was a featured "teller" in October at Peninsula College. As she states, she comes from sturdy stock. One of her ancestors, Penelope, was taken by Indians in the days before US Independence and eventually escaped back to her family. A lively, silver-haired and knowledgeable woman, Clara Carlson is certainly an inspiration to all freethinkers.
