I wasn't surprised to read from the BBC News website late last month that The Equality Act before the House of Commons in Britain was meeting significant resistance from primarily the Catholic Church. The Act, due to come into effect in April in England, Wales and Scotland but already in effect in Northern Ireland, would outlaw "discrimination in the provision of goods, facilities and services on the basis of sexual orientation" and would finally allow British gays the right to adopt chil-

nature and trash. Statistics consistently indicate that 98% of those who hold the beliefs of a particular established religion acquire those beliefs through their immediate family or their endemic culture. Liberal Democrat Member of Parliament Evan Harris had a good suggestion to avoid this foolish influence of religion which harms families and children in the future-simply replace religious organizations who provide

# Meeting Recap **A New Year's Resolution** By Kevin Schultz

Susan Mogull spoke to 40 members of AOF on Jan 14 on the topic, *Religion and the Public Schools—A New Year's Resolution To Support Freedom of Conscience.* 

Her talk focused on proselytizing,

praying, the pledge of allegiance, religious clubs, celebrating, and studying about religion

Ms. Mogull brought considerable knowledge to her talk. She is president of the Sacramento Chapter of Americans United for Separation of Church and State and a member of Americans United's National Advisory Council.

A former teacher, Ms. Mogull is Capital Region Leader of the California 3Rs Project, a statewide organization that provides training for educators on religion and the public schools. The region includes eleven counties. Since her appointment in 1996, she has arranged

Dr. Vermeij was born in the Netherlands and spent school years growing up in New Jersey. He received his bachelor's degree from Princeton University and a Masters and doctorate from Yale. He worked at the University of Maryland from 1971 to 1988 before moving to UC Davis, where he has been named by his peers as a Distinguished Research Professor. He has a fascinating career story, as told in Chapter 11 of Portraits of Great American Scientists ("Seeina with His Hands" by Elizabeth Gilbert). There one can learn answers to the questions she poses: "How could a blind person ever aspire to become a scientist? Of all the sciences, why would a blind person choose to study biology, the most visual of all the scientific fields?"

Here is how Professor Vermeij summarizes his plans for Sacramento's Darwin presentation (I've highlighted my own interest): The study of evolution is a science of history. The shells of mollusks - snails, clams, and their relatives - offer a window on this history. By examining their architecture and interpreting blemishes on their surfaces, we can deduce which challenges were important in their evolution. Among (Continued on page 7)

### Fiery Fundamentalist Fooled Followers for Forbidden Fling? Sister Aimee By Ken Nahigian

Aimee Semple McPherson (1890-1944), American radio evangelist of the 1920s and 30s, was an eloquent woman, and young, and cute. In Los Angeles she founded a huge temple and the Foursquare Gospel Church. Each week thousands flocked to hear the Pentecostal preachings of "Sister Aimee": Bible, baptism, sanctification of the Spirit, glossolalia, faith healing and imminent Armageddon, all peddled with showbiz flair and wrapped in a winning smile.

But in 1926, she vanished quite mysteriously. What happened?

Aimee liked to swim. On May 18, she left her secretary on the beach, swam into the ocean, and did not return.

Searches failed to find a body. Followers kept vigil on the shore. Tongues wagged. Newspapers churned out extras. Some thought she drowned, others suggested sharks. Cynics called it a stunt. From across the country came in sightings—more than Elvis got, in fact.

On June 20, McPherson's mother received a ransom note from "the Avengers." It demanded \$500,000.

Three days later, Aimee turned up in Agua Prieta, Mexico, a border town, with a bizarre story. A couple had lured her into their car, she said, with a story of a dying child; chloroforming her, they drove her to a desert shack and held her prisoner. But when they left for supplies, Aimee cut her bonds on a jagged can lid, then trekked across the desert to collapse at the gate of a house.

No one could locate the shack,

though. Also, after the long hike, Aimee was not dehydrated or sunburned, her shoes unscuffed, her dress unstained. The story had other flaws. Police investigated and reporters dug for dirt. Finally someone found that Aimee had spent ten days in Carmel, California, with her radio engineer, apparently engaged in carnal communion.

A grand jury hearing became an inquest. A woman claimed Aimee and her mother had bribed her to say that she, not Aimee, had been with the secret lover. Despite protestations, the jury indicted the evangelist for obstruction of justice. The story grew into an embarrassment for Los Angeles civic leaders. Finally the district attorney dropped all charges, saying evidence was too conflicted and confused for prosecution.

What *really* happened? After a 1970s TV movie starring Faye Dunaway, and another film in 2006, the sense of it is still thin. The kid-nap-yarn was silly, but if Aimee only wanted a tryst with her secret boyfriend, she could have found easier ways. Beyond the guesses, no one knows.

Later the same year, mystery-writer Agatha Christie pulled a similar vanishing stunt. Many have wondered if she took a hint from Sister Aimee.

Aimee McPherson returned to preaching, but the controversy dogged her. In 1944, she died of an overdose of barbiturates. Rumors whispered suicide, though most called it accidental—at least that is what the coroner ruled.

As for the International Foursquare Gospel Church, it continued under the direction of her son. Today worldwide membership tops three million.

the most important perils to which mollusks and other life forms must adapt are predators, whose nature and importance have changed in predictable ways through time. The study of mollusks reveals important historical trends in how organisms adapt, and these trends in turn teach us a great deal about our own future. One of the greatest challenges to life is unpredictability, a phenomenon that is highly resistant to adaptation; yet life has survived through many rare, unpredictable crises, and its strategies of adaptation to everyday phenomena teach important lessons about how life copes with the unforeseen events in history.

There are plenty of perils today. Do "lessons learned" at the Darwin Day 2007 educational gala have anything to say to us about forthcoming chapters in the story of human history?
