# **Global Warming**— **Carl Zichella Confronts Climate** Crisis **By Kevin Schultz**

"[Inaction on global warming] is absolutely unacceptable. We know we're creating this problem, we know we have the solutions at hand. To allow future generations

to live greatly diminished lives knowing the things that we know-that we have the tools to solve this problem—I believe is profoundly immoral and profoundly unethical."

From misters at the Eiffel Tower to retreating glaciers along the Himalayan plateau to 120° Fahrenheit summers in South Dakota, Sierra Club Regional Staff Director Carl Zichella de-

scribed the current global climate situations.

He listed a canary in the coal mine as the melting of the ice shelves in Antarctica.

He asserted that scientific and technological revolution combines old habits with new technologies, allowing us to become more and more efficient with habits contributing to environmental change. Near the end, Mr. Zichella de-

bunked several misconceptions about the science behind global

warming.

Mr. Zichella listed several ideas and resources to help reduce global warming: realclimate.org, new hybrid car engines, wind technologies, compact fluorescents, and biofuels. He noted 20% of all energy in California is used to move



## Historical Figures Series Holes In Their Heads: The Pseudoscience of Trepanation By Ken Nahigian

# Editors note: Squeamish stomachs beware!

The things I've done. Weekends with fans in garish costumes and plastic pointed ears, debating continuity lapses of a TV science fiction series. Earnest, disconsolate deconstructions of a comic-book hero's fictional "origin." Forums of enthusiastic living-history recreationists, dissecting the minutiae of garb, art, etiquette and language. I have listened, interacted, even sympathized, until my eyes glaze like polypropylene marbles and the pupils contract to mere dots.

I confess and admit: at heart I am a crank, with a penchant and love for crankism. In the boiler room of subcultural obsession, I've stood in the fulminous chemical bath, and even enjoyed it.

But I have my limits.

"Dr." Bart Hughes, a Dutch savant, apparently did not. In the 1960's his obsession was infant mentality. Children, he noted, are enthusiastic for life, flexible and joyous, creative and open to possibility. Adults are brittle, pessimistic, self-limiting, stodgy. Why? It was a fair question, but his answer was odd. It's all a matter of Brainbloodvolume, Hughes decided, our ability to deliver oxygen to the brain. The young have softer skulls, flexing slightly with each heartbeat: the old do not. As the cranial sutures close, as the brainpan calcifies, we slowly starve for oxygen, until our sense of life withdraws, diminishes, to a narrow and blinkered focus we call "maturity."

The solution? Bore a hole.

Following his intuition, Hughes trepanned himself (i.e., opened his skull) under local anesthesia. Recov-

ering, he felt he had found a kind of spiritual ecstasy, an enhanced consciousness. He preached and wrote. The ensuing publicity cost him his medical degree, plus a stint in a lunatic asylum, but he gained a disciple: namely Joey Mellen, Oxford graduate and bohemian proponent of LSD therapy (remember, it was the 60's). Convinced that the "third eye" of yogic mysticism was more than a metaphor, Mellen was sure trepanation would open his own at last. But how to proceed? Curiously, British surgeons were unsympathetic to the plan.

An undaunted Mellen found an antique trepan instrument in a surgical store, a kind of hand-worked auger or corkscrew. With this, an anesthetic syringe, his girlfriend's help, but absolutely *no* medical training, he went to work.

The first two efforts were dismal failures. His 1972 book, Bore Hole, described the successful third attempt. "After some time there was an ominous sounding schlurp and the sound of bubbling. I drew the trepan out and the gurgling continued. It sounded like air bubbles running under the skull as they were pressed out. I looked at the trepan and there was a bit of bone in it. At last! ... Amanda was sure I was through. There seemed no other explanation of the schlurping noises. I decided to call it a day. At that time I thought that any hole would do, no matter what size. I bandaged up my head and cleared away the mess."

The surgery left a sense of well being, but Mellen wondered: was a bigger hole better? Later, alone, he tried again—with a power drill. "This time I was not in any doubt. The drill head went at least an inch deep through the hole. A great gush of blood followed my withdrawal of the drill. In the mirror I could see the blood in the hole rising and falling with the pulsation of the brain."

It was all he had hoped. During the next four hours his spirits rose and rose, until he found a state of freedom and serenity which, he claims, has been with him ever since.

His impressed girlfriend subsequently followed suit, even filming the process. Released as "Heartbeat in the Brain," the film became a cult classic, which you will sometimes see at movie art houses. It shows Amanda at work in a bloodspattered white robe. Calmly, as the soundtrack floats with soft music, she shaves her hair. makes the dermal incision, and drills. Blood spurts as she penetrates the skull. She sets down the drill with a triumphant smile. But be warned-the film has been cause for fainting. At one London showing a critic described the audience "dropping off their seats one by one like ripe plums."

Bart Hughes, the guru who began it, died in 2004. Joey and Amanda, now separated, continue to preach the trepanation gospel. Old friends describe them as pleasant, serene and normal. They have lectured widely, even to doctors, and support the International Trepanation Advocacy Group (trepan.com). ITAG boasts about twenty cases of voluntarily skull-boring, all claiming to be happy with the results. And of course, it sells T-shirts.

### Pillosophy – A New Branch of Philosophy? By Paul Geisert

Pillosophy is a branch of philosophy wherein the pillosophers administer verbal pills to cure deviations from what they firmly know is in the best interests of others. Currently pillosophy is focused on the concept of religion.

Three pillosophers who are currently getting a lot of press are Richard Dawkins, Sam Harris. and Christopher Hitchens. Their pillosophy pills are simple. Properly administered, everyone in the world would instantly understand that it is ridiculous to be religious. However. the pills would need to be administered on a gigantic scale, since there are over 4 billion religious individuals who hold concepts that pillosophers deem wrong, ill bordering advised, on mentally ill, and/or dangerous.

Critics of pillosophy claim that lumping all religious individuals under the term "religious" presents serious prob-

lems. For example, many individuals are barely religious, some are sort of religious, some are barking bonkers religious, and so on. That calls for small, medium, and large pills. Currently all types of people are simply lumped under "religious" and prescribed a pill. The direction on the label states: I know what is best for you, so take this pill and live happy in truth.

There is the problem that "normal philosophy" has great difficulty even identifying what "religion" is! (see Jeffrey Brodd, AOF speaker in 2004)

Many religious individuals are not believers in a god. For example, mil-

lions

of

their time thinking and talking about non-existent gods they don't believe in (atheists). This will be a tough one for the pillosophers since the behavior is widespread but not viewed by them to be very deviant. Perhaps a pill would simply erase the concept of "god" from their mental database, thus freeing them from a lifetime of non-productive behavior.

This leaves us with the need for a pillosophy pill to cure the four billion whose worldview includes both religion and a belief in god (s). This might be a horrendous task if a unique pill is needed for each god (there are 99 names of god in the Qur'an alone). Clearly various pills will need to be developed to cure those who believe in X god but not Y god.

> Perhaps the easiest solution would be to provide a pill to the pillosophers themselves! Then

they would stop making sweeping generalizations about religion and religious beliefs, and start focusing on specific social actions (such as separation of religion and government).

Alas, it is probably impossible to get pillosophers to think practically. After all, pillosophy is a branch of philosophy, which after over 2,000 years is discussing the same questions.

Buddhist, Jain, Confucian, and Jewish individuals do not embrace a god. Furthermore, the Brights movement has many individuals who selfidentify as "religious" (Catholic, Protestant, Jewish, etc.), but have a naturalistic worldview and register as Brights.

There is also the situation where individuals spend enormous amounts of

of mobsters, those who nailed him silent. And each of those who used perverse devotion


to him as reason to snuff out the Light of Alexandria
