

Keeping AOF Alive For Another 15 Years **AOF Line** By Paul Storey

Our founders formed an organization that brought atheists and freethinkers in the Sacramento area together, allowing a community of like-minded people to meet and share ideas, listen to interesting speakers, and participate in various activities throughout the year. So far it has lasted 15 years, a notable achievement, something I think is highly worthwhile to continue for another 15 years. I would sure like to see this happen. I like AOF and

love the speakers. Many AOFers are the people who think the most like I do, who are the only ones within driving range that I can get together with in any given month and discuss issues near

and dear to my heart, and to give me lots of information in return that I may not have known about without them. It keeps me full of cheer that I am not the only atheist in a world gone supernaturally whacko.

A number of energetic people put a lot of their time into keeping the organization going. Over the years, many of these people cut back their time they chose to give to AOF and became less active, many to where we don't see a lot of them anymore, regretfully. I'm sure this phenomenon is not unique to our organization but happens everywhere. It has to do with changes people go through in life, readjusting priorities, and looking for new stimulus in new friends and new places, all which is very natural. Also, there may be phenomena of burn out. When we put too much time into one activity, sooner or later we reach a point that economists call diminishing returns, where what you put in doesn't equal what you get out, or where your time could be more fulfilling elsewhere, and the desire to continue breaks. Then you drop out of that activity or direction in life, and pursue the many other fascinating and rewarding possibilities available to us all.

Rather than have any members over commit their time then burn out. I

> would like to see us have a balanced budget in everybody's time spent participating in, or volunteering to, AOF. Let's call it a 15 year plan. Rather than put in a lot of hours for a

few years then get burned out and disappear, I would like us all to think in terms of how many hours per month am I willing to put into AOF for the next 10 years. A steady churchgoer puts in a couple of hours a week, roughly eight hours a month. They can continue doing this their whole life, without getting too saturated, bored or tired of seeing the same church, the same priest, the same people or the same god.

That is what I would like us to do. Think about how much you enjoy being around non-god-delusional people, and how many hours a week or a month you are willing to put in, over the long run, to participate in this group and help to keep it alive. One or two hours a week is usually fine with anybody, ten hours or more is usually a strain everybody.

Historical Figures Series **A Family Schism—Herbert W.Armstrong** By Ken Nahigian

The original Worldwide Church of God, founded as the Radio Church by Herbert W. Armstrong in 1933, a global faithempire of over 120,000 members, three "Bible colleges" and two public journals, which upheld its founder as God's own spokesman, taught that Anglo-Britons were the true Jews, and evoked cries of cultism, racism and heresy from other Christian groups—that church is gone. Truly gone. By bits it has schismed, splintered and evolved, diluted or cast off its more radical teachings, and melted into the mainstream like an arabesque of ice. But the history is colorful, and scandalous: a story worth telling.

Young Herbert Armstrong, slim, wellmannered, soft-voiced and handsome, was the stuff of an ideal salesman. Born to a devout Quaker family in Des Moines, Iowa, on July 31, 1892, he attended the First Friends Church. Though studious, he never finished high school. At age 18, on an uncle's advice, he quit to work for a local newspaper. Experience in advertising impressed on him the yet-untapped power of the media.

On a trip he met Loma Dillon, a schoolteacher and distant cousin from Motor, Iowa. They wed on his 25th birthday. Settling in Chicago, they had their first child, Beverly, in 1918, then fled back to Des Moines to escape the flu epidemic. A second daughter, Dorothy, was born in 1920. After business setbacks the family moved to Oregon in 1924, where Armstrong found a renewed passion for advertising. Here they had two sons, Richard David and Garner Ted.

About then he began using the middle initial "W." It was a conceit—in fact, Herbert Armstrong had no middle name.

Loma had joined a Seventh-day Adventist offshoot sect. The couple argued over the proper day of Sabbath: Saturday or Sunday? With business in a lull again, Herbert found time for Bible study. Intending to refute Loma, he found himself refuted. Nowhere did the Bible redelegate the Sabbath day! For Herbert it was a revelation, an epiphany. Slowly he grew sure that God had opened his eyes to deep truths most churches had forgotten or buried.

In 1927, baptized, he joined his wife's church; in 1931 it ordained him a minister. As Armstrong preached he continued his study, uncovering new revelations. Concerned about the growing flights of heterodoxy, in 1937 the church revoked his credentials of ministry.

Armstrong shrugged. By then his radio ministry was in flower. A local radio station had offered airtime for devotionals. After positive feedback, the station had commissioned a new program, "The World Tomorrow," on the first Sunday of 1934. So was born the Radio Church of God. Other stations soon picked it up. Armstrong began publication of *The Plain Truth* magazine, free subscriptions to all on request. With these media vehicles, Armstrong grew his empire.

In 1946 Armstrong moved to Pasadena, California, a conservative community. A year later he opened the doors of Ambassador College, his new Bible college. (It had four students.)

Church and media empire grew over the next two decades, until the broadcasts reached Africa, Australia, the Philippines, Latin America, England and continental Europe. Armstrong interacted with political leaders such as Indira Gandhi, Anwar el-Sadat and Ferdinand Marcos.

In a 1956 booklet, titled *1975 in Prophecy!*, Armstrong wove his own ministry into a florid vision of World War III, end times and Armageddon. Typical of his style, the booklet made heavy use of upper case and bold case words, exclamation points and biblical numerology. The public gobbled it up, but mainline Christian leaders found it troubling and irksome.

A problem was his theology. Beyond standard Adventist ideas such as the Saturday Sabbath, Armstrong taught Anglo-Israelism, the notion that the British Anglo-Saxons were a Jewish Lost Tribe, God's chosen people, and the true heirs of Israel. He denied the Trinity, stressed strict sexual mores, rejected most holidays, rejected medical treatment, demanded "triple tithing," and insisted that much of Mosaic Law, particularly the Levitical food regulations, was still in force.

Loma died in 1967. The next year Armstrong renamed his church the Worldwide Church of God. By 1970 it was clear that Armstrong's prophecy was not unfolding as claimed. Criticisms grew; then scandal rocked the church. Piece by piece, the empire began to crumble.

First his son: Garner Ted, charismatic, outgoing, the heir apparent. In 1972 Armstrong announced that Garner was "in the bonds of Satan" and was discharged of all church duties. Rumors spread of adultery and gambling. In 1978 Armstrong excommunicated him. In response Garner Ted started his own church, the Church of God International, in Tyler, Texas. They never reconciled; even Armstrong's own official autobiography only mentions his birth.

Next, claims of financial fraud, prompting the state of California to put the church in receivership. Then in 1977, to the shock of church members, Armstrong married a woman nearly 50 years his junior, and worse, a *divorcee*—something church doctrine forbade. In 1980, a former church minister accused Armstrong of incest with his daughter, Dorothy. Neither Armstrong nor the church ever denied this allegation.

A final scandal came in 1982 when Armstrong divorced his wife in a lengthy, ugly legal battle. Despite it all, the church continued to grow, at each turn redefining or interpreting some basic teachings, drifting into the mainstream, and disaffecting older members.

In August 1985, Armstrong's published his last work, *Mystery of the Ages*, a "synopsis of the Bible" and summary of his theology. The next month, health failing, he dropped from public view. On Jan 16, 1986, nine days after naming a successor to run his church, Armstrong died, age 93.

Since then, the church has splintered and schismed. The "main" (largest) body has renounced most of Armstrong's stranger doctrines. Over a dozen groups now claim to represent his true ministry, accusing each other of compromise and heresy.

It's an old story, faith a soil for division and factionalism. But after all, "heresy," from the Greek *hairetikos*, "able to choose," and *hairesthai*, "to choose," had a simpler original meaning: a heretic was one who decides his own way. Freethinkers will understand. To think for yourself—what can be more tempting?

At least, Herbert Armstrong thought for himself. We'll give him that.

Thanks in large part to Matthew's courage and tenacity, a Student Education Assembly on Religious Freedom was created at the school.

AOF Hosts International Atheist Humanitarian Dr.Vijayam of Atheist Centre, India—June Visit Recap

AOF DID SOMETHING NEW FOR US IN JUNE- we enabled the visit to Sacramento by The Director of the internationally known Atheist Centre of India. Donors paid his airfare from MN, where he had been hosted by Atheists for Human Rights. We hosted his lodging and his food. We arranged for our Free Thought community to meet him, and we arranged for him to speak at The Forum. We would have liked to see more public turnout for the latter.

We arranged an interview of Dr Vijayam by our own Mynga Futrell, which was shown on Channel 17 in Sacramento. In addition, we raised \$450 for the work of the Atheist Centre.

I think all of us who were involved got as much out of this as we gave. It was inspiring to see what can be done when there is a common purpose and devoted commitment and focus, as there has been by Dr Vijayam's multi-generational family since 1940. They have created an effective social reform institution that is a model of Humanism in action, and one very committed to advancing secular rationalism in society. And, one that has gained acceptance and recognition by their government and around the world.
