Measure Will Determine Incumbent Candidates' Standing

AOF Bylaws Amendment

Summary

- Strikes sentence "No director shall serve more than three consecutive years." from AOF bylaws.
- Calls for 2009 board of directors to implement an alternative term limit plan, which will be brought for a vote before the AOF board elections for 2010.
- Approves standing of incumbent candidates Mynga Futrell, Don Knutson, and Ken Nahigian for AOF board elections for 2009.
- Incumbent Paul Storey chooses not to run for re-election if amendment approved.

Full Text of Proposed Amendment

The approved AOF board motion reads:

"To put to a vote of the general membership to strike the final sentence from Article 3, Section 4 of the amended bylaws, which states, 'No director shall serve more than three consecutive years.' The 2009 BoD will develop an alternative term limit plan, which will be brought for a vote before next year's election."

Text of Proposed Bylaws Change

SECTION 4. QUALIFICATION AND TERMS OF OFFICE

Any member in good standing may serve as director of this corporation. Each director shall hold office until the next annual meeting for election of the Board of Directors as specified in these Bylaws, and until his or her successor is elected and qualifies. No director shall serve more than three consecutive years.

Paul Geisert

Paul elected to verbally present his candidate statement to the members, an option available to all candidates.

Nancy Gilbert (incumbent)

I accept the opportunity to be a Board candidate. If so honored by your vote, I would like to see us: #1. Encourage our mutual sociality in positive ways; we need to re-evaluate our format and add activities, and have more fun. #2. Enlarge and activate our membership. #3. Improve our organizational functioning and direction, and #4.Remember our stated mission of AOF. As part of it, I feel we need to refute that pervasive assumption that a moral sense and ethical behavior is dependent on a god-belief. This, I believe, has little basis in fact; there is ample evidence that humans have at least some genetically programmed sense of justice (unfortunately, not uniformly coded!), and that early childhood inculcation and continual modeling is extremely important. I feel we should call attention to this whenever possible; it goes to the basis of our political and sometimes social exclusions; it would not hurt us to demonstrate it either. I have time and energy to give to working to invigorate AOF.

Don Knutson (incumbent)

I have been an active AOF member for 13 years. I have served for several years on the Board, for one term as Board Secretary and for two terms as President. I also coordinate AOF's Adopt-A-Highway program and our Davis Community Meals volunteer work. He was also responsible for convincing About.com to feature an Agnosticism/ Atheism page, and was its first "guide." He also served on the board of Northern California Publishers & Authors for three years. Currently, he does volunteer work as a suicide prevention counselor, is a volunteer Big Brother, and works full-time for the California Hospital Association.

His second published book, ONE NATION UNDER GOD, is a dystopian novel that deals with an Ameri-

can theocracy in the near future. The book was published in 2004 and has won multiple awards while maintaining a five-star rating on Amazon.com.
