

Neutrality in Public Education

A Gaping Chasm

Public schools, like any governmental entity, are supposed to be impartial with respect to the array of belief systems present in America's diverse landscape.

The schools are *not to privilege* any religion, no matter how widespread or influential it may be. This means treating religion in curricula with academic accuracy and detachment. It means teachers being impartial regarding the various beliefs they may encounter in their students.

The idea that schools are not to privilege one religion over another grows out of the decisions of the U.S. Supreme Court since 1947. That was the year the Court first set forth the *neutrality concept* (in the case of *Everson v. Board of Education*), and that concept has since been the criterion of settling court cases on the relationship of religion to government and to the public schools.

In general, public school administrators and teachers know about their legal responsibility to be neutral. Of course there are those who fail to take this responsibility to heart. (Exceptions are usually where one religion holds strong sway in a homogeneous community.)

What teachers often don't know about, however, is another pairing that derived from *Everson*: the one between "faith and no faith." Public schools are expected to be *neutral* there, too. That is, just as the schools are not to privilege any religion over another, they aren't to privilege religion generally over nonreligion either.

To teachers, this necessity for religion/nonreligion neutrality can be, and frequently is, a startling and disquieting notion!

The constitutional guarantee of religious freedom for "all faiths or none" presents an unmistakable chasm for many teachers. Why? Because there's a yawning cultural gap that rests right at the "or" in that phrase.

The "faith/no faith" fissure in society is robust. Frankly, it's not an easy crevice for educators to bridge.

The legal and social ideal may be neutrality, but the linguistic and cultural terrain on the two sides is simply *not* the same. And a teacher will typically live on one side or other of that chasm. (*Part 3 in this mini-series will focus on the terrain on either side.*)

"A Gaping Chasm" is the second in a series of mini-commentaries on society and education by Mynga Futrell, Ph.D., director of OABITAR (Objectivity, Accuracy, and Balance In Teaching About Religion). They are adapted from an article published in the quarterly of the California 3Rs (Rights, Respect, Responsibility) Religious Liberty Project in May 2008.

Dr. Carrier is a graduate of UC Berkeley and Columbia University, and is the author of Sense and Goodness without God, and a contributor to The Empty Tomb, and has authored numerous monographs and articles on religious history, the origins of Christianity, and the defense of naturalism. He is on the advisory board of Internet Infidels, an educational organization which owns and maintains the Secular Web, "the most comprehensive freethought resource on the Internet," for the purpose of promoting the naturalistic worldview. Historical Figures Series The Rainbow Man By Ken Nahigian

Rollen F. Stewart did love Jesus, at first with a modest, low-key, church-on-Sundays love. But when life took a bad turn, the love grew madder, deeper, more frenetic; and it got tangled with a hunger for attention, a desperate drive and a mutant hysteria that showered pinwheel sparks and left scorches all around him. For Rollen, it was a very bad mix.

Born in Spokane, WA, in 1945, he had a troubled childhood. His parents were alcoholics. His father died when he was seven, his mother died in a house fire when he was 15: his sister died, strangled by her boyfriend, the same year. He grew into a shy, subdued man, prone to moods. When he married his first love and opened a racing shop, his fortunes seemed to change. But she left him. Devastated, Rollen sold the shop and moved to a mountain ranch to farm marijuana, try to grow the world's longest mustache, and watch television. Lots of television.

TV gave him ideas. At some point he decided to find fame by donning a loincloth and rainbow-Afro wig, and popping up at televised sporting events. His plan was to parlay notoriety into a commercial career and riches. Rollen worked at it for four years. But beyond a brief spot in one Anheuser-Busch commercial, and a few token party gigs, it didn't happen.

Instead he became a figure of fun. The 1980 Super Bowl in Pasadena was a sea change. "I had gone in my fur loincloth and wig," as he wrote later. "The girls loved it. Everywhere I walked, they were patting my butt. I could have held a thousand women in my arms that day, yet I walked out of there sad. It was the shallowness. I was being seen


all over the world, but never as myself."

That night in his hotel room, watching a televangelist show, he found his epiphany. "I fell to my knees there in that room and allowed Jesus to take control of my life..."

And so, driven by Jesus, subsisting on donations, a meal a day and massive doses of pot, Rollen began his mission. He hit an average of twelve sporting events per month. Gone was the loincloth, gone

the goofy and raucous antics. But he kept the rainbow wig and chrome-bright manic grin, and he added new accoutrements: T-shirts blazoned with Christian mottos, and placards reading JOHN 3:16 ("For God so loved the world, that He gave his only begotten Son, that whosoever believes in Him shall not perish, but have everlasting life").

The Rainbow Man or "Rockin' Rollen" Stewart, as he was soon known, drove up to 50,000 miles a year to pop up at baseball and football games, golf tourneys, the Olympics, the Indy 500, the Kentucky Derby, NBA and NCAA basketball finals, the Stanley Cup, political conventions, even the wedding of Princess Di and Prince Charles. He refined

techniques for grabbing the television limelight. Fame grew, of a sort. Shows such as "Saturday Night Live", "St. Elsewhere" and "The Tonight Show" featured caricatures of him; cartoonist Charles Shultz even put him in a "Peanuts" comic strip. Officials came to regard Rollen as a pest, often sending security guards to eject him.

In 1984, in Virginia, he met Margaret Hockridge, a school teacher. She was in awe. The couple married in St. Louis ten months later. She wore mauve, he a JESUS IS COMING t-shirt. Together they continued the blitzkrieg for God.

But his instability, the crests and (Continued on page 5)

troughs of mania and despair, soon wore on Margaret. At the 1986 World Series, when she stood in the wrong spot with her placard, an enraged Rollen tried to choke her. By 1990 she had filed for divorce. Rollen began an emotional freefall.

To draw more attention, he tried threats, smoke bombs, stink bombs, buzzers and a remote-controlled air horn. He planted a stink bomb in the Crystal Cathedral in Garden Grove. At the 1990 American Music Awards, he tried to toss skunk sacs into the audience. Police arrested, detained and released him with warnings, thinking him a mostly harmless crank. But he went too far in September 1992. Sure the Rapture was due within days, he took a house-maid hostage at a Los Angeles Hyatt Hotel, lit two small fires, and held off a police SWAT team for 10 hours. The motive: "To get the word out."

Courts sentenced Rollen to three life terms for the kidnapping, plus five years for the stink bombs. Sympathizers found it excessive; others thought it overdue. "This is not Bozo the Clown," said the District Attorney; "He is a very sick and dangerous man." In fact the *LA Times* reported he had plotted assassinations of Presidents Bush and Clinton. A showman to the end, Rollen punctuated the sentencing with a wild, rolling end-of-the-world rant.

Still in prison, last denied parole in 2005, Rollen is sadder, not wiser—sad that he miscalculated the date of Armageddon, sad his daughter has no truck with him. But he has inspired a coterie of born-again exhibitionists to carry on his message. At the next game, scan the lower bleachers, just beyond the goal posts. You might glimpse a rainbow 'fro, a crystal-bright grin and a John 3:3 placard. It is not Rollen. But it is his spirit, radiant and wild, ranting on
