In 2007, some fundamentalist Christian students and community citizens organized and targeted non-Christian students and other minority groups at American River College with malicious propaganda. Over the course of the next year, these individuals garnered local and national media attention for their continued efforts. During this time, faculty, staff, and administrators came together to promote an atmosphere of civility, respect, and the free exchange of ideas in accordance with the college's stated values. One early attempt at promoting these ideals was **Professor Natasha Fratello Breitenbach's** panel on Questions of Faith. The panel was comprised of local religious leaders plus Hank Kocol, a representative of Atheists and Other Freethinkers. The professor will talk about her choice to get involved,




the original panel and other efforts that followed, and give an update on the campus atmosphere today.


Rasputin: The Unkillable Monk By Ken Nahigian

Born into squat poverty in the flyspeck village of Pokrovskoye, in a Siberian fairyland where the crackle of winter ice is like gunshots and summer is a bog under clouds of midges, he grew up to a singular truth: to live you must have blood of iron and flesh of flint. Grigory Efimovich Rasputin did. By mid-age he was the most notorious monk ever, of Russian Orthodox flavor at least. The tales told-of his physical strength, tireless fornications, mystical ecstasies and rages, nearhypnotic hold on the Russian royal family, ability to dine on cyanide or take dagger wounds to the stomach or absorb high-caliber bullets and spit them out like melon seeds-and not least, that windstorm-style beard, those black, sucking, manic eyes-have been the very fabric of nightmares, and still scare Russian infants into eating their beets.

He was born on January 10, 1869. His parents were Efim and Anna, normal, respected villagers. His siblings, sister and brother, died young under tragic circumstances. Around age 18 he spent penance time in a monastery, perhaps for a theft, and befriended a local hermit, and may have been involved with a flagellant/orgiastic sect, the Khlysty. It all may have inspired him to become a mystic and pilgrim. Leaving home in 1901, he walked to Greece, Jerusalem and St. Petersburg. On the way he built a reputation as a healer and visionary, and left a trail of deflowered maidens.

During his Siberian peregrinations, destiny found him. He caught news of Alexei Nikolaevich, the Tsarevich (Romanov heir apparent). Ill with hemophilia, the blood disorder, little Alexei would soon die—so said the helpless doctors. Rasputin saw opportunity. At the capital he fostered links to the St. Petersburg Seminary and presented himself as Fa-

ther Gregori, a holy man. Soon he drew disciples, pious nobles and desperate peasants who sought healing, advice and absolution. He made political connections. From his modest flat, Rasputin let out word that he could heal the Tsarevich. Caught up by his commanding manner and weird self-conviction, and verged on despair, the Empress Alexandra begged him to try. Remarkably, he succeeded. "Father Gregori" helped Alexei through several painful attacks of internal and exter-

nal bleeding. Precisely how is unknown. Was it hypnotism, folk medicine, luck, prayer? Or was it simply that he withheld aspirin, the painrelieving wonder drug of the day, which actually exacerbates hemophilia? But as a result Rasputin gained a foothold in the royal court, then another, and became a periodic visitor, and grew in power. Not all were pleased.

For one, he was *scary*. He had stern convictions, spiritual and political. He showed no especial deference for royalty, speaking gruffly and frankly to the Tsar as if to a peasant. Even at court functions he wore the same black tar boots, the same ragged overcoat. Amid the royal murk and intrigue, Rasputin glittered, sharp and deadly as a knife in an alley.

There were rumors of magic, of course; even the Archbishop of Russia thought the monk could call thunderstorms at whim. He had a talent for seeing emotional flaws and hairline cracks, and exploiting them. His fanaticism was contagious, the kind that calls and breeds other fanatics.

The carousing and unfettered womanizing was awkward too, by a bit. Rasputin had a secret doctrine—to reach salvation through sin. With his dark magnetism, he easily convinced young women to help him seek God. (This line has never worked for me; it had to be the delivery.)

Despite this, and despite public rebukes from officials and even the Holy Synod, his hold on the Tsar's family was unshakable. No doubt it helped to be the sole hope for Alexi's life. But when the Great War began, Rasputin went too far. He advised the Tsar to take direct command at the front. With the Tsar away, he convinced Alexandra to replace some public officials with his own hand-picked candi-

Again Buddha by a miracle escapes from the tyrant of Madura, Zoroaster foils the King, Bacchus laughs at the rage of Cadmus, and Chrishna eludes the ty-

This is the festival of the sun-god, and as such let its observance be universal.

This is the great day of the first religion, the mother of all religions -- the worship of the sun.


Sun worship is not only the first, but the most natural and most reasonable of all. And not only the most natural and the most reasonable, but by far the most poetic, the most beautiful.

The sun is the god of benefits, of growth, of life, of warmth, of happiness, of joy. The sun is the all-seeing, the all-pitying, the all-loving.

This bright God knew no hatred, no malice, never sought for revenge.

All evil qualities were in the breast of the God of darkness, of shadow, of night. And so I say again, this is the festival of Light. This is the anniversary of the triumph of the Sun over the hosts of Darkness.

Let us all hope for the triumph of Light -- of Right and Reason -- for the victory of Fact over Falsehood, of Science over Superstition.



And so hoping, let us celebrate the venerable festival of the Sun.

dates. As he imposed his iron will, his enemies began to move.

In December, 1916, three nobles lured Rasputin to the Yusupov Palace on pretext of meeting the Tsar's beautiful niece. The monk had once survived a dagger stab from a former lady friend, deep enough to expose entrails, so the nobles took no chances. Awaiting the tryst, he munched tea cakes and wine, supposedly laced with enough cyanide "to kill five men." It had no effect. In dismay, one noble pulled a pistol and shot the monk point blank. Rasputin fell, got up, looked at him with those poisonous black eyes, then slammed him to a wall and began to throttle him like a chicken. The nobles fought off the angry monk and chased him outside. They shot him three more times, once in the head; clubbed him bloody; wrapped him in a sheet and threw him in the icy Neva River. Officials recovered the body later. The cause of death? Drowning.

To be fair, some of the details are apocryphal and disputed. And the story omits a lot—for example, Rasputin actually had a wife, Praskovia, who gamely endured his shenanigans ("He has enough for all," she said), and a son and daughters in Pokrovskoye. One daughter, Maria (d. 1977), eventually became a cabaret dancer in Bucharest, a performer with Ringling Brothers, and finally an American citizen in 1945. She claimed to possess her father's huge phallus, preserved in a jar of formaldehyde. In the 1970's she sold it to an antiques dealer. In 1994 an unidentified collector asked the Bonhams auction house to test what he thought was the relic—it was a sea cucumber. A Russian museum now claims to have the true relic.

It makes a grand end to the story, one of the cases where the myth seems truer than history. What better destiny for the unwashed, half-crazed, oversexed iron monk, who unwittingly helped bring down the Romanov dynasty, than his member to become a museum piece, a prize sought by collectors? Truly he would be proud.

December Meeting Write-Up

Matt McCormick, CSUS Professor of Philosophy, gave a great presentation on the content of his upcoming book about the evidence (or lack thereof) for the divinity of Christ. If Matt's class lectures are anything like his talk at AOF, his classes must be very popular.

Matt came at the subject from many angles, but primarily looked at the most basic tenet of Christianity, the resurrection, and at what grounds exist for believing that it occurred. He pointed out that the four gospels were written many years after Jesus' life, and that two of the authors (Matthew and Luke) relied heavily on the earlier version written by Mark. None of these authors knew Jesus, and there's no way of knowing how many people the stories passed through before they were recorded by the gospel writers of the NT. Matt then gave an example of a bag of money changing hands multiple times to illustrate the extremely low probability that information can be passed through multiple sources without data loss or change.

He also spoke about the reliability of the miracle-witnesses, and used an analogy (the "miracles" at Lourdes) to make the point that the odds are infinitesimally small (.00000165 chance that the Lourdes miracle testimony is reliable) that real miracles were being performed by Jesus.

Another aspect Matt included was the evidence from the Salem Witch Trials. He pointed out that the events surrounding the witch trials were exceedingly well-documented, but that despite this wealth of eyewitness reports that magic/ witchcraft was occurring, very few people believe today that the people executed in Salem were actually guilty of the crime of witchcraft. The evidence of Jesus' supernatural works is orders of magnitude less than that of the Salem witches' magical works.

The talk ended with a hypothetical situation: you are arrested and (falsely) accused of murder. The prosecution provides testimony from four men. It comes out that none of them saw you do it, or have ever met you. They heard you did it from some people who talked to some other people.... Then it comes out that the supposed crime happened many years ago. Two of the men got their stories directly from one of the other men. There are still many discrepancies in their stories. Then they put a surprise witness on the stand (Paul) who had a vision in a trance, and a voice told him you did it. He says everyone knows you're guilty. The jury finds you guilty. When asked why, they said they just had faith that you did it, and they were always taught that you had done it, and you might have done it (and they couldn't let a guilty person go free), and no one can prove that you didn't do it. Of course, it was a Christian jury.
