Leo Igwe Will Speak!

Leo Igwe, humanist and human rights activist, has been executive director of the Nigerian Humanist Movement, director of the Center for Inquiry Nigeria, the Western and Southern African representative to the International Humanist and Ethical Union, and serves on the Atheist Alliance International Council. He has worked tirelessly to end numerous human rights violations and oppression, including homophobia, ritual killings, human sacrifice, hysteria about sorcery and witchcraft, abuse of albinos, caste discrimination, "child witch" pogroms and anti-blasphemy laws. He has often been arrested, his family persecuted, for his atheist and humanist activism.

An eloquent, well-spoken humanist, Leo Igwe is perhaps the most prolific writer in the world on atheism and humanism with respect to these human rights violations, and has been praised as an advocate for justice and the value of human life.

Katherine Stewart: The Good News Club

"Give us a child until he is seven," the Jesuits famously said, "and we will have him for the rest of his life." According to author <u>Katherine Stewart</u>, evangelical Protestents have torn this leaf from the Jesuit book, focusing their missionary efforts on children who are easy to intimidate and who yet lack critical thinking skills. In 2009, she and her husband Matthew had personal experience with this, when a group called "The Good News Club" tried to set up a so-called "nondenominational Bible study" group at their seven-year-old daughter's grade school.

I'm sure you've all seen TV advertisements for collections of religious music. "Songs 4 Worship" and the like, filled with the typical smarmy pap you hear on contemporary Christian radio stations.

Most of these commercials show at least one shot of a church congregation, the people all with their eyes closed, heads tilted back, some with arms in the air, and all with expressions of what some might call euphoria on their faces.

But that glazed, oblivious expression reminds me more of the faces of some of the stoners I knew in high school. It's almost like they're high.

And interestingly enough, a friend of mine recently told me about a show he watched on addiction. An opening scene evidently showed a series of shots of the types of things you'd expect: alcohol, drugs, gambling... but it also showed a shot of one of these "euphoric" church congregations!

Though I personally do not imbibe or partake, I consider drug use to be a personal choice. If you want to be a user, go right ahead. Unless you're putting others in danger because of it, I frankly don't care. It's your body, your mind.

This is how I view religion, as well. I don't care what other people believe, so long as they're not harming others due to their beliefs or trying to push their beliefs on others. And if one's religion causes harm to others, it should be treated no differently than when someone is harmed by any other addict. Being drunk, for example, is not an excuse if you hurt someone. You're still responsible for your actions. Likewise, "because the Bible says so" is no excuse, either.

I'd like to see extreme religiosity treated just like any other addiction. They should have their own version of the Betty Ford Clinic... maybe a Dan Barker Clinic!

Many addicts are unaware of, or in denial of, their addictions. Such a clinic would be the perfect place for them to go. They'd have no access to their holy books, to religious television or radio. Certainly, they'd be denied their "Songs 4 Worship" CDs. (Give them one of the freethought CDs that Dan has written and recorded.) Instead, they'd be in an atmosphere of reason, surrounded by former religion addicts who can explain to them how they've been deceived all these years. They'll have books at their disposal, a library of rationalist literature and science texts. There will be a huge museum of natural history that shows quite plainly how Noah's flood couldn't have happened.

These are just a few ideas off the top of my head, but I like where it's going. I'll check with Dan and see what he thinks.

In the meantime, consider doing something to help one of your addict acquaintances. Bring them to an AOF meeting!

It turned out that the Good News Club was actually a program of the Child Evangelism Fellowship (CEF), founded in 1937 with a very specific and deeply fundamentalist agenda. Its self-declared mission "is to produce conversion experiences in very young children and thus equip them to 'witness' for other children." Good News Clubs are established in public schools across the nation, and few children are spared their attention, not even Christian children who fail to share their particular shade of religious ideology. Sophisticated stealth tactics bamboozle the children (and parents) into thinking the Clubs operate under color of the school's authority -- but in fact, their ultimate goal is to shut down the public school system.

In the aftermath, Katherine wrote <u>The Good News Club: The Christian Right's Assault on America's Children</u>, a hair-raising account and exposé of this mostly under-the-radar effort to evangelize children in public schools.
