"Ask The Social I.Q. Lady"

Some people argue from a "position" rather than arguing the "issue".

Positional arguing is when each side takes a position, argues for it, and makes concessions to reach a compromise. For example, when it comes to abortion, one side claims "abortion is wrong no matter what" and the other side might state "abortion may be wrong sometimes (like late-term abortions) but should remain legal". Still others would argue "abortion is nobody's business except the pregnant woman's".

When people argue over positions they tend to lock themselves into those positions. If you believe abortion is fine if done within the first trimester but not after, the other person will try to "bargain" with you: "what's the difference between two months, twenty-nine days and three months, four days?", and so on. These types of "bargaining" are not useful on arguments of issue.

Religious beliefs interfere with critical thinking. Most Christians believe that life begins at conception. They have little to no understanding of the stages of life. They don't understand or even acknowledge undifferentiated cells in stem cells. Without proper education of the issue, they can only argue their position.

No protester is going to change his or her mind with a sharp barb directed at their lack of knowledge on this issue. Do the right thing by saying nothing and walk on by. If you do want to say something, ask a simple question like "can you explain to me what embryonic stem cells are?" or "did you know that 25 per cent of all pregnancies spontaneously abort before the woman even knows she's pregnant?"


Sometimes, the best thing is to avoid an argument when it's obvious that one is arguing from a position of extremism or stubbornness. The issue is usually not the problem for them, their religious ideals are.



Juvenile Hall Update By Judy Saint

The voice behind the blackened window told me to have a seat with my box of 10 books. She'd be out from behind the locked doors in a few minutes to retrieve it.

The only other person waiting on the hard metal mesh seats was a lady who struck up conversation about the nice mural painting on the wall. Since I didn't say too much more, she again struck up conversation a minute later asking if I was a volunteer here. In retrospect, with so many people coming and going wanting to see their sons and daughters, I guess it was the box that said "Contents: I0 Books" that made her ask that. Maybe I just didn't look like I was visiting anybody in jail.

She asked what sort of volunteering I did. "Trying to help the girls with critical thinking, being able to think for themselves. Basically, to give them some encouragement about their lives, that they were born beautiful and worthy." She asked if I did this on the street. "No, I just come here. But there is a whole community out there who tries to do good for people all the time, who think this way." She maintained her look right into my eyes, with a sweet need to talk. I finally added passively, "We're atheists. We're good people, despite what you hear about us." She admitted shyly, but still looking right into my eyes that she didn't know what that word really meant, and waited for me to explain. I did the "without a god" thing. That broke the dam. She began telling me, quietly, how she thinks churches really do damage to people. I tried to gently add a comment here or there, but she didn't stop to let me. She had a few quiet comments about not really liking churches anymore and she had wondered what this atheist thing was. It was all in whispers.

At that point she was called to enter the metal detector area to go inside the locked doors for her visit. She kept looking back at me, saying one or two words with every turn. Finally, in such a polite demeanor said, "It was really nice meeting you" as she was escorted in. She stopped, turned again just before the door shut and added, "I'll see you later." She didn't want the connection to end with a goodbye. It meant too much to her. I said I'd see her later, too.



The first question the Court must answer is whether for-profit corporations have religious rights. Though *Citizens United* related to corporations having free speech in campaign finance, one can see the Court expanding the other First Amendment right of free exercise of religion to corporations. However, allowing the owners' religious beliefs dictate the operations of the corporation blurs the line shielding owners from liability for the actions of the corporation--largely why businesses incorporate.

If corporations do have such rights, then the question becomes whether the mandate under Obamacare is the least-restrictive means towards a compelling government interest under the Religious Freedom Restoration Act. Cheaper healthcare costs and providing vital services to women via the mandate may be compelling interests, but the millions-of-dollars penalty Hobby Lobby faces in not complying may be overkill. Moreover, because Obamacare exempts churches from the mandate, one may wonder whether the interests above are that compelling after all.

It is difficult to predict an outcome. Chief Justice John Roberts surprised everyone in 2012 in upholding Obamacare as constitutional, though he and Justice Anthony Kennedy are both sympathetic to the view of corporations as people. Justices Ruth Ginsberg, Sonia Sotomayor, and Elena Kagan were adamantly opposed to Hobby Lobby during oral argument.

This battle between workers' and women's rights versus corporations and the Religious Right should alarm all freethinkers, as religious beliefs of our employers could dictate how we live our lives. If Hobby Lobby succeeds, there is no clear limit as to what employers could deny their workers in the name of religion.

California "Department of Bad Bills" By Tom Manger

This past month we've been busy putting together letters of support and letters of opposition for the many bills we are tracking. The week of April 21st, the Secular Coalition for California will be at the statehouse in Sacramento to oppose two different sectarian bills being vetted at committee hearings.



The first bill being discussed, AB 1934, would give religious organizations additional privileges in the way that they hold assets. This bill would allow religious organizations to bypass decisions meted out by the California Secretary of State regarding "corporation sole", an arcane area of corporate law used by many of the larger hierarchical religious groups. It would also recognize canon law for succession of the single person in control of the corporation sole and all associated assets. The Secretary of State has already weighed in stating that corporation sole should be eliminated because of "corruption and money laundering". We'll be there to concur.

The second bill, SB 978, requires an understanding of current law for the problem to present itself. Current law states that whenever a rape victim presents at a hospital for treatment, a law officer must be brought in for evidentiary reasons. And, that law officer is required to contact a local rape crisis center so that the rape victim counselor can be made available on site. This bill being considered will allow hospitals to contact the rape crisis center directly therefore bypassing the law enforcement officer.

This second bill seems innocuous when taken at face value. The problem is when a rape victim presents at a religious hospital. Most of these hospitals don't allow doctors to fully discuss medically available options such as emergency contraception. And, since there are an estimated 25,000 pregnancies each year due to sexual assault in the U.S., access to full medical information is needed should a victim become pregnant.

Our concern is that this bill would allow religious hospitals to call in their own religiously driven rape crisis counselors. We know that Crisis Pregnancy Centers already use misinformation, medically inaccurate information, emotional pleas, shaming and religious fervor to sway their clientele away from abortions. We don't want rape crisis centers using the same techniques. Wish us luck in sending these bills to the dust bin of history!
