#### "Ask The Social I.Q. Lady"

Dear Social I.Q. Lady,

My family members are always trying to make me feel guilty for not participating in their religious affairs, most recently, a baptism. I don't want to go, but now I do feel guilty about not "supporting" their "celebrations". What should I say to them?

-Not Guilty

Dear Not Guilty,

You have no obligation to attend anyone's social or religious ceremonies especially if it conflicts with what you stand for. Insisting you go is tantamount to insisting a vegetarian who is a dinner guest in your home try your roast beef. Guilt is something we should only feel when we've actually done something wrong, like committed a crime or some kind of offense. People play the "guilt card" in order to get others to comply with their wishes. They want you to attend their ceremony so they resort to emotional manipulation. Once you understand that's all it is, it will be easier to respond in a caring, calm, and most importantly, rational manner. Next time you're asked to do something or go somewhere which conflicts with your principles, explain your position once, then let it go. For example: "Thank you for inviting me to little boo-boo's baptism. I'm not able to attend, but I'd be happy to join you later for a piece of cake." Of course, you would modify your response to something that fits your particular situation. In this way you are showing your love for your family (or friends) without compromising your values. Many atheists have no problem attending religious ceremonies. It doesn't matter what others are comfortable doing, it only matters what you find acceptable for yourself. Don't allow the feelings of others to dictate your emotional responses. If you have strong convictions about something, then you have nothing for which to feel guilty.

It's secular, for sure, with no mention of gods, religion, or spirituality. But it doesn't exist to provide a platform to disparage religion or even discuss it. There are plenty of other great groups for that. Sunday Assembly serves a different purpose: with its motto to "Celebrate Life", it focuses on the great things people are doing and seeks to inspire others to do the same. It is "radically inclusive" and strives to create something that anyone can enjoy.

Andi Griffith, John Lucas, and Rick Tracewell rocked the secular congregation with songs from Journey, Billy Joel, and more, encouraging everyone to get up off their feet and sing along.

Even children were entertained thanks to the volunteer efforts of Laura Hitchings and others from Camp Quest West – providing much-appreciated childcare during the hour-long service.

Following the service, attendees stayed for a potluck, to mingle and make new friends – one of the most cherished reasons people attend church. Although the service ended at 11:30 AM, the potluck stayed strong well into the afternoon.





#### Juvenile Hall Update

What begins with "attitude" as they walk into the classroom – each trying to act cool by ignoring me just a little, trying to sit with others they know will chat off topic with them – very quickly turns into a frenzy of hands in the air.

Being invited to the hall began when one of the officers was fed up with the hellfire and damnation she heard religious preachers yell at the girls, every few days, week in and week out. The final straw was hearing the preacher tell the boys the bible instructs them to dominate women. The atheist officer then created a weekly class of her own, built acceptance over months for her new class idea which she based on general life skills, to get it approved, then carefully brought in her first atheist guest (me). She had me back a second time months later. Then, having proven interest from the girls, she launched her big idea she had been planning all along: A regular spot for an atheist to come in just like the churches do. We finally have that now. We were just last week approved for a class with our own regular time slot.

Maybe someday we will have enough non-theist volunteers to hold the class weekly, but for now I'm proud to announce that "Freethinkers Class" begins in October, after almost a year of careful planning. Why would a class require a year of planning, you might ask? In the name of retaining authority, religion seems to have a stranglehold on what is expected out at the hall. Fiery indignation, shame and name-calling in the name of Jesus seem to have been tacitly approved as the modus operandi for the detention facility. Without religion and shame, how can anyone turn their lives around, they seem to think. Thanks to this one officer, at least now once a month the girls in one unit will have a place to go to hear the "real" good news — that they can be responsible for their own lives and hold their heads high despite those who try to shame them, yell at them or threaten them with fairytale torture.

If you are interested in joining me for a visit, just let me know. We'll keep it just females for now, while we set up this program slowly. Whether a one-time visit, or eventually getting your own permanent visitor's badge and time slot, the girls' responses to what you have to share will make your day.

Our thoughts have always been free. When we realize thinking is good, that listening to the propaganda religion propagates is bad, we have taken the first step to freedom.


Now the next step is the hardest, that is taking your life into your own hands. You've always known that being morally good has nothing to do with religion, but society has bought into the lie. Examine that thought.



#### **Legal Watch** By Arash Khosrowshahi

In honor of Freethought Day it is important to focus on the roots of American religious liberty, particularly as it germinated from the work of James Madison. Considered the Father of the Constitution, James Madison was one of the principle writers of The Federalist Papers after he wrote extensive notes at the Constitutional Convention Debates. Though at the time of the Constitution's ratification James Madison was not in favor of a Bill of Rights (viewing it to be a superfluous statement of rights the people had guaranteed under the state constitutions and under the system of checks and balances of the Federal Government), it was a political concession he promised the Anti-Federalists in order for the 13 states to join the newly-created Union. Once adopted, however, James Madison continued to focus on the issue of religious persecution, an issue he had worked against as far back as 1774 in Virginia.

The religious minorities at the time were Presbyterians, Lutherans, and Baptists, which were and are different sects of the Christian religion. Today religious diversity in this country has expanded far beyond particular sects of one religious tradition, and though freethinkers do not lump themselves in this category, it is important to realize that the legal basis for our freedom of religious belief or no religious belief is also guaranteed by the same Free Exercise Clause that James Madison fought for as part of the Bill of Rights over two centuries ago.

We as a group may not have even been considered to fall under that rubric all those years ago, but we nevertheless should pay homage to a Founding Father whose work helped forge our liberties today as we persevere to combat religious establishment and discrimination against us in the future.

#### Department of Bad Bills By Tom Manger

August 31st was the last day that the California Assembly or Senate were able to debate and vote on legislation. Of the bills that passed both of these houses, Monday, September 30th marked the last day that Governor Jerry Brown could sign these bills into law or to veto them. Here are highlights of some of the bills that made it to the governor's desk...

In California, this was an amazing year for same-sex marriage equality; protection of women and children from sexual assault or abuse; expanded sex education; and women's increased access to reproductive healthcare.



Regarding same-sex marriage, SB 1306 was passed earlier this year and officially makes marriage in California a gender neutral event. A marriage is no longer defined as being between a man and a woman. It is now a civil contract between two persons regardless of gender. The vast majority of LGBT weddings are civil (aka nonreligious) ceremonies. With the passing of AB 1525 this month, civil ceremonies will be easier to schedule (sans religious celebrants) now that "city clerks" have been added to the list of government employees who can solemnize a wedding. Next year the SCCA is hoping to significantly expand this even further by adding "public notaries" to the list of people able to solemnize a civil wedding in California. On our upcoming Advocacy Day (Oct 13th) we will be looking for legislators to sponsor this piece of legislation on our behalf.

Senator Holly Mitchell pushed through a bill that mandates the inclusion of all FDA approved contraceptives, voluntary sterilization and comprehensive contraceptive counseling without restrictions or cost sharing (copays) in all health insurance policies in California (excepting houses of worship and certain religious nonprofits.) This puts all plans on par and eliminates exclusions. And, should a woman get pregnant, if she is eligible for CalWorks public assistance, thanks to AB 1579 she will be able to receive additional benefits for her infant starting in the second trimester.

AB 2016 and SB 1165 add to sex education curriculum the topics of sexual abuse and sex trafficking. This is an effort to raise awareness of these problems and provide victims (and potential reporters) with resources in which to direct themselves.

The threshold for consensual sex on campus used to be described by the saying, "No Means No." But, SB 967 requires universities, colleges and postsecondary schools to establish and enforce an affirmative consent policy. You will soon start seeing and hearing the term, "Yes Means Yes" to describe these new policies. For woman who end up victims of domestic abuse or sexual assault several other bills make new resources and procedures available to help them through the array of available Rape Crisis Centers, Family Justice Centers and violence peer counseling

Children are further protected from abuse through two new bills (AB 2560) & AB 1432) that enforce mandated child abuse reporting by school employees and teachers - some of the people most likely to identify a problem. And, should a child be victimized, SB 926 by Senator Beall changes the statute of limitations from age 26 to age 40 for those victims who want to bring charges against the perpetrators. Unfortunately, a companion bill SB 924 was vetoed by the governor. This bill would have extended the statute of limitations for bringing charges against any private institutions liable for having allowed child sexual abuse. (The Catholic Church lobbied hard against this bill.)

California has made a lot of forward progress in replacing sectarian laws with research based provisions that promote the welfare of all. Stick around for more adventures next year. And, if you're able to, join us on Advocacy Day on Monday October 13th when we visit all legislative offices to show them the issues important to us.

And, as a final observation, not only is California moving towards a healthier future, they are pushing back against a harmful past. This year AB 2444 passed and prevents the Confederate flag from being sold on any merchandise, political items and sports memorabilia sold through government venues such as gift stores at public museums. This is definitely something worth leaving behind.
